All opportunities over £10,000 will be offered to suppliers either through an existing government contract or by placing an open advertisement on <u>Contracts Finder</u>, which is the government portal for all public sector opportunities. In relation to existing government contracts, when an opportunity is offered through contracts or frameworks held by the Dept. for Business Innovation and Skills, or Crown Commercial Service (CCS) then the advertisement of the opportunity is handled through those organisations. CCS has produced guidance on becoming a CCS supplier, available here.
