## **RETURNING RESIDENTS**

#### **REFUSAL FORMULAE**

PLEASE NOTE: The following wordings are examples - they do <u>not</u> constitute an exhaustive list of all possible formulae.

### **ON ENTRY**

"You have asked for leave to enter the United Kingdom as a returning resident....."

#### Not settled when last left

"... but I am not satisfied that you had indefinite leave to enter or remain in the United Kingdom when you last embarked."

#### Paragraph 320(9) with reference to Paragraph 18(i)

{Refusal Code: F4}

#### More than 2 years away

"...but I am satisfied that you have been away from the United Kingdom for more than 2 years and, having considered the circumstances of your case, I am not prepared to exercise discretion in your favour."

## Paragraph 320(9) with reference to paragraph 18(ii) and 19

{Refusal Code: F4}

#### Public funds

"...but I am satisfied that you received assistance from public funds towards the cost of leaving the United Kingdom."

#### **Purpose not settlement**

"...but I am not satisfied that you are seeking admission for the purpose of settlement."

## AFTER ENTRY

"You have applied for indefinite leave to remain in the United Kingdom on the basis that you were previously settled here..."
