Further to your recent email regarding our proposed improvements for the A27 Chichester Bypass. Highways England is responsible for handling and responding to correspondence regarding the consultation and scheme on behalf of Ministers.

Thank you for your request for information about what were the estimated costs of the original northern bypass Option A. We are dealing with it under the terms of the Environmental Information Regulations 2004, this is because the information requested concerns measures and activities affecting or likely to affect elements of the environment or affect factors such as noise, pollution discharges and other releases into the environment.

The information you have asked for is supplied below.

## Option A

- · High speed interchange provided west of Chichester prior to Fishbourne Roundabout
- New alignment north of Chichester bypassing all six existing junctions
- · High speed interchange provided east of Chichester past Boxgrove Roundabout
- No intermediate junctions / interchanges considered
