Part surrender

We have decided to accept the surrender of part of the permit for Calvert Landfill operated by FCC Waste Services (UK) Limited.

The permit number is EPR/BS8605IQ

The application surrender reference is EPR/BS8605IQ/S012

The land to be surrendered has not been landfilled. The part surrender is to remove Pit 6 from the current permit. Calvert Pit 6 is a pre-operational area of the site which has not received wastes and therefore this application is for low risk partial surrender. Environment Agency Guidance note, RGN9, Version 3, May 2013 identifies that low risk surrender is appropriate for areas of land at landfill installations that are outside the areas used for the permanent deposit of waste.

This surrender application is processed in parallel and to coincide with the determination of an application for a new installation permit for Pit 6 Application ref: EPR/BP3637AF/A001.

The Pit 6 area is a former clay extraction, which is partially flooded and remains an unutilised void adjacent to the landfilled Pit 5. The monitoring data collected as part of the routine monitoring for the current landfill permit indicates that there is no impact from the Pit 6 area of the site.

The Pit 6 area of the site has no source for potential contamination therefore there is no potential source-pathway-receptor linkage and surrender of this area of the site is considered acceptable as a low risk surrender application. Alongside the surrender of this pre-operational site area the listed activity (A2) for development of a stable non-reactive hazardous cell in Pit 6 is also to be removed from the current permit (EPR/BS8605IQ) as a pre-operational surrender.

We consider in reaching that decision we have taken into account all relevant considerations and legal requirements.
