An application has been made by the Heron Wind Limited, Njord Limited and Vi Aura Limited ("the Project One companies") to the Secretary of State for Energy and Climate Change to make a non-material amendment to the above mentioned Development Consent Order (DCO). The application seeks to make non-material amendments to the DCO to increase the length and area of the Offshore High Voltage Alternating Current (HVAC) Collector Substations (OSS) platforms and the length width and area of the Offshore HVAC Reactive Compensation Substation (RCS) platform. The applicant also seeks to amend Requirement 10 within the DCO which refers to no part of the works below Mean High Water Springs (MHWS) commencing without an approved decommissioning programme, to refer instead to the mean low water mark.
