FOOTPATHS CP-514 (PART), IN THE PARISH OF CLEEVE PRIOR

PUBLIC PATH CREATION AND DEFINITIVE MAP MODIFICATION ORDER 2013

This Order is made by Worcestershire County Council ("the authority") under Section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that, having regard to the matters set out in Section 26(1), there is a need for a public footpath over the land to which this Order relates, and that it is expedient that the footpath should be created.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the County of Worcestershire definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) of the 1981 Act, namely, the creation (as authorised by this Order) of a new right of way over land in the area to which the map relates, being a right of way such that the land over which the rights subsists is a public path.

Wychavon District Council has been consulted as required by Section 26(3) of the 1980 Act.

**BY THIS ORDER:**

1. There shall be at the end of twenty eight days from the date of confirmation of this Order a public footpath over the land situated in the parish of Cleeve Prior described in Part I of the Schedule to this Order and shown by a broken line on the map attached to this Order, and thereupon the County of Worcestershire definitive map and statement shall be modified by adding that path or way to it, and the definitive statement shall be modified as described in Part 3 of the Schedule to this Order.
2. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

## SCHEDULE

### PART 1

#### Description of Site of New Footpath

##### FOOTPATH CP-514

The length of footpath CP-514 (part), in the parish of Cleeve Prior, has a width of 2 metres and commences at Ordnance Survey grid reference SP 0830 5017 (point A on the Order plan). The path proceeds in a generally south south westerly direction, along a track up a slope through woodland, for approximately 105 metres. The footpath then turns to head in a generally south south easterly direction, for approximately 20 metres, to terminate at Ordnance Survey grid reference SP 0828 5005 (point E on the Order plan), at the junction with bridleway CP-519.

The total distance of the footpath is approximately 125 metres.

##### FOOTPATHS CP-514 (FORMERLY FOOTPATH NO. 3)

#### LOCATION

Commencing at the county boundary on the south bank of the River Avon 100 yards west of the boathouse, Marlcliff, being a continuation of footpath in Bedford parish, Warwickshire, path runs west through a coppice for 360 yards, then follows the river bank gradually bearing south to **Ordnance Survey grid reference SP 0830 5017**. The path continues, with a width of 2 metres, in a generally south south westerly

direction, along a track up a slope through woodland, for approximately 105 metres. The footpath then turns to head in a generally south south easterly direction, for approximately 20 metres, to terminate at Ordnance Survey grid reference SP 0828 5005. A second section commences at Ordnance Survey grid reference SP 0804 4993 to until it joins footpath 1 at the south east corner of Cleeve Hill.

DESCRIPTION

General

High stile, on county boundary, muddy track in grass between left bank of river Avon and edge of wood, for 300 yards gap, muddy track in grass, gap, grass, gap, remains of fence on ground, grass field, stile in barbed wire fence parallel with river, 18 yards wide strip rough ground between fence and river, wicket gate off one hinge, ~~up bank of pasture, over old line of hedge, to fence with one strand of barbed wire across, irregular and overgrown path through scrub and bushes for 100 yards, pig wire fence, followed after 20 yards by tree across track up slope through woodland.~~ **Second section more defined track edge of wood by river for 70 yards, past ferry boat, grass, car parking ground, junction with footpath No. 1 by remains of Cleeve Hill.**
