

NOTICE OF ORDER

HIGHWAYS ACT 1980 SECTION 119

Essex County Council
Public Path Diversion Order 2016 Footpath 31 Stanway in the Borough of
Colchester

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 2 November 2016.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert public Footpath 31 in the parish of Stanway in the Borough of Colchester.

A part length of Footpath 31, commencing from grid reference 59635,22128 on the north side of the stile and running in a northerly direction to the east of the dovecote and on the west side of the property known as Olivers for a total distance of 180 metres to grid reference 59653,22132 where it connects with Footpath 22 Stanway, will be diverted to an alternative route commencing from the aforementioned above point and running in a westerly direction along an existing permissive path for a total distance of approximately 111 metres to grid reference 59665,22146, where it connects to Footpath 22 Stanway, but 172 metres further to the south-west than the current path.

Any person wishing to view the statements of case and other documents relating to this Order may do so by appointment at The Definitive Map Service Department, A2 Seax House, County Hall, Market Road, Chelmsford, Essex CM1 1QH during normal office working hours.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 16 November 2016]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 28 December 2016]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

Within 14 weeks of the start date [by 8 February 2017]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

**PUBLIC PATH DIVERSION ORDER
FOOTPATH 31 STANWAY**

This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any expenses which are incurred in the order making and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Colchester Borough Council have been consulted and have consented to the making of the Order as required by section 120(2) of the 1980 Act.


BY THIS ORDER:

1. The public right of way over the land situated in the parish of Stanway in the Borough of Colchester known as Footpath 31 and shown by a bold continuous line on the map numbered STAN 31 A contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.

2. There shall at the end of 28 days from the date of confirmation of this order be a public footpath over the land situated in the parish of Stanway in the Borough of Colchester known as Footpath 31 described in Part 2 of the Schedule and shown by a bold broken line on the map numbered STAN 31 A contained in this order.

Diversion of Footpath 31 Stanway

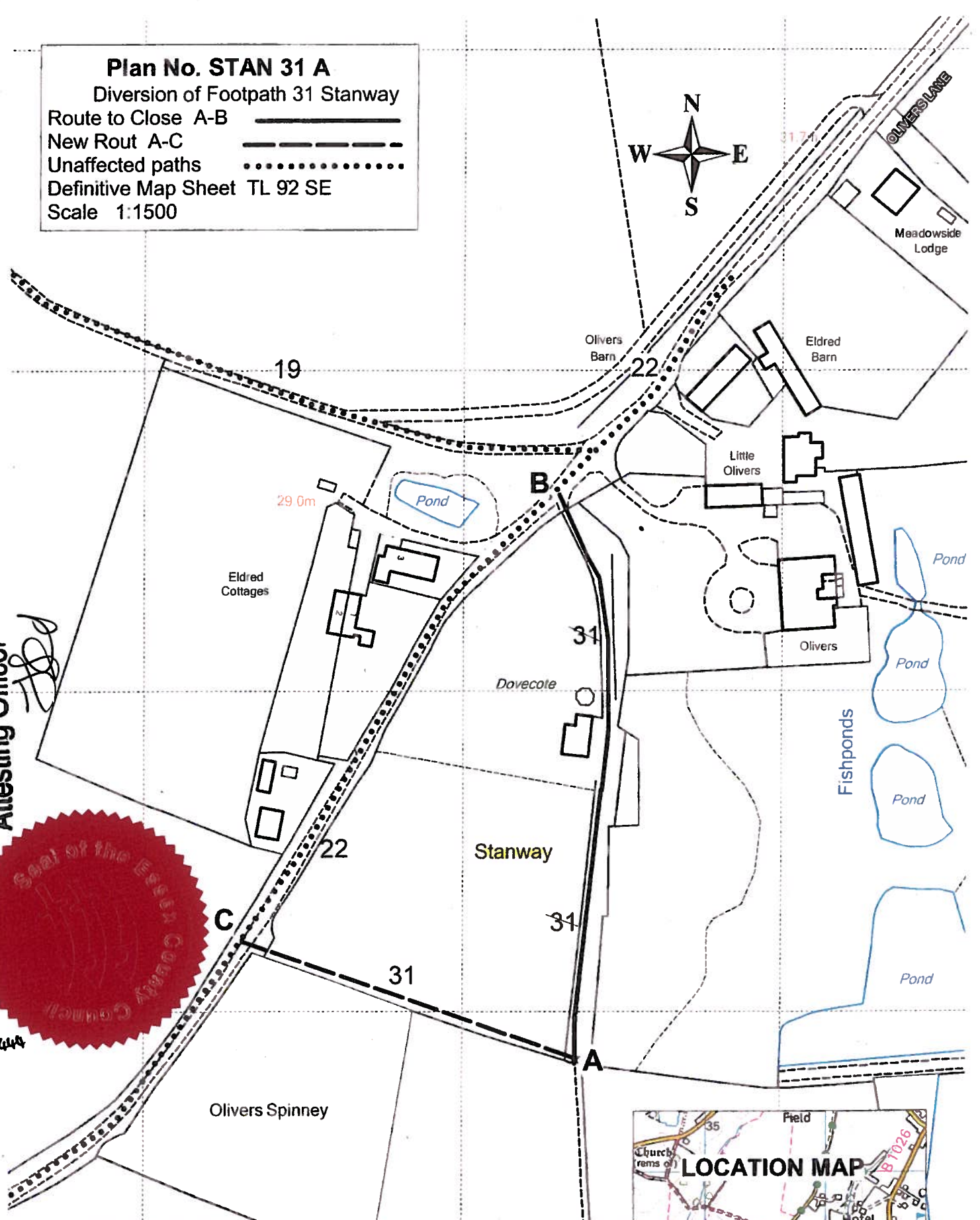
Route to Close A-B 

New Rout A-C 

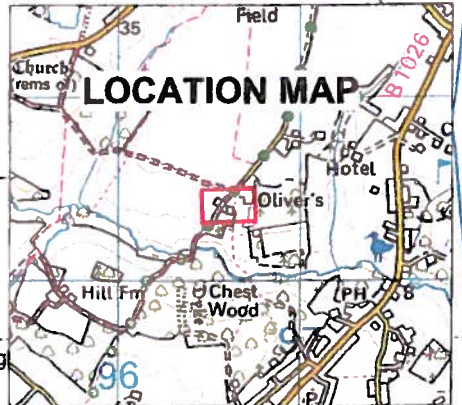

[PART 1]

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 31 Stanway of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 59635,22128 on the north side of the stile running in a northerly direction to the east of Dovecote and on the west side of the property known as Olivers for a total distance of approximately 180 metres to point **B** at grid reference 59653,22132 where it connects with Footpath 22 Stanway.

[PART 2]

DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the order map commencing from the aforementioned point **A** running in a westerly direction along an existing permissive path for a total distance of approximately 111 metres to point **C** at grid reference 59665,22146 where it connects to Footpath 22 Stanway being approximately 172 metres further to the south-west than the current path.
