Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

#### The start date for the above Order is 08 December 2015.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert Public Footpath No. 34 Consett Parish from a point south west of 12A Valley View, Leadgate (Point A at grid reference 412349.551377) proceeding in an east-south-easterly direction for a distance of some 38 metres to the junction with Public Footpath No. 35 (Point B at grid reference 412383.551363) to a line running from the same point south west of 12A Valley View proceeding in a south-south-easterly direction for a distance of some 36 metres (to Point C at grid reference 412365.551345) then in an east-south-easterly direction for a distance of some 32 metres to join Footpath No. 35 south of the junction (Point D at grid reference 412393.551338), as shown on the order map.

As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

#### Within 14 weeks of the start date [by 15 March 2016]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties <u>everyone should keep to the timetable</u> to ensure that statements of case and comments are received on time.

All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.
