

# NOTICE OF ORDER

## HIGHWAYS ACT 1980 SECTION 119

Isle Of Wight Council  
Public Footpath N206 Woodside Beach Wootton  
Isle of Wight Diversion Order No.1 2014

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **12 November 2015**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert a section of Public Footpath N206 **from** a point on Public Footpath N206 approximately 183m north east of its junction with Lower Woodside Road and heading in a north east direction initially along a tarmac surface for 3m; then a gravel track for 17m; then crossing a 4m wide tarmac access road; then along a gravel track between hedges for approximately 75m, then continuing for 2m down three concrete steps to the beach **to** a point on Public Footpath N206 approximately 183m north east of its junction with Lower Woodside Road and heading north west along a tarmac road (with a width of 3.75m) for approximately 50m; then heading north east along a gravel track (with a width of 3.75m) for 12m to a 1.5m gap between a tree and a wooden gate post; then continuing north east along a gravel track (with a width of 3.75m) for 35m; then continuing along a gravel track in an east south east direction (with a width of 3.5m) for 21m; then continuing along a gravel path in a north east direction (with a width of 4m) for 33m to the top of a flight of steps from which point the path continues in two separate directions; (i) continues north east down the flight of approximately 18 steps to reach the beach, and (ii) continues down a bank (with a path width of 1.5m) initially in an east direction for 6m then in a north west direction for 6m to rejoin the same point on the beach at the bottom of the flight of steps; the path then continues along the beach adjacent to a low timber sea defence wall in an east south east direction (with a width of 2m) for 21m to the bottom of 3 concrete steps.

### **Timetable for sending in statements of case and comments**

#### **Within 2 weeks of the start date [by 26 November 2015]**

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

#### **Within 8 weeks of the start date [by 07 January 2016]**

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

#### **Within 14 weeks of the start date [by 18 February 2016]**

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time.

All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.
