THE KENT COUNTY COUNCIL (PUBLIC FOOTPATH ER183 (PART) ALKHAM) PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2015

This Order is made by the Kent County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of Public Footpaths ER183 should be diverted.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement for the County of Kent (Map Sheet 161 [TR24SE]) requires modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

The applicant has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and pay any expenses which are incurred in bringing the new site of the public right of way into a fit condition for use by the public:

Dover District Council has been consulted as required by Section 120 (2) of the 1980 Act;

BY THIS ORDER:

- 1. The public right of way over the land situate at Alkham and shown by a bold continuous line on the attached map contained in the Order and described in Part I of the schedule to this Order shall be stopped up from the date of confirmation of this Order, and thereupon the Definitive Map for the County of Kent (Map Sheet 161 [TR24SE]) shall be modified by deleting from it that public right of way.
- 2. The relevant date of this Order will be as specified in paragraph 1.
- 3. There shall be from the date of confirmation of this Order a Public Footpath over the land situate at Alkham described in Part II of the schedule and shown by a bold broken line on the Map contained in this Order, and thereupon the Definitive Map for the County of Kent (Map Sheet 161 [TR24SE]) shall be modified by adding the path to it.
- 3A. The Definitive Statement for the County of Kent (Map Sheet 161 [TR24SE]) shall be modified as described in Part IV of the schedule to this Order.

PART I: DESCRIPTION OF SITE OF EXISTING PATH OR WAY

The entire width of that length of Public Footpath ER183 which commences at its junction with Public Footpath ER162 at NGR TR 2556 4236 and runs in a generally north-easterly direction for approximately 145 metres to NGR TR 2548 4248, as shown between points A and B on the Order plan.

PART II: DESCRIPTION OF SITE OF NEW PATH OR WAY

A new length of Public Footpath numbered ER183, with a width of 2 metres, which commences at the previously described point B (NGR TR 2548 4248) and runs in a generally south-south-westerly direction for approximately 61 metres to NGR TR 2546 4242 (point C) and then continuing in a generally south-westerly direction for approximately 73 metres to a junction with Public Footpath ER161 at NGR TR 2541 4237 (point D).

The section of Public Footpath ER183 between its junctions with Public Footpaths ER161 and ER162 (between points E and A) is renumbered to become part of Public Footpath ER162.
