Thank you for your e-mail of 28 July on Business Appointments, in response to the reply you received to your previous request of 20 July. Your email has been treated as a request for information under the Freedom of Information Act 2000 (FOIA).

You asked for:

*....."a rethink of one aspect of the section 40(2) exemption relating solely to the names of the prospective employers. So for the 380 or so applications could you release the names of these prospective employers without releasing the names of the individuals who made the application. Once this personal data is "anonymised" I would argue that the exemption no longer applies".*

Please find attached a table outlining the names of prospective employers and the numbers of applicants. In line with MOD policy on the release of statistical data relating to personnel, the numbers provided have been rounded to a multiple of 10 to prevent the inadvertent disclosure of personal information either now or in the future (when it might be combined with other information yet unreleased). Similarly, where numbers are less than 5 these have been replaced with a tilde (~).

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1<sup>st</sup> Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail [CIO-FOI-IR@mod.uk](mailto:CIO-FOI-IR@mod.uk)). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
