# 1. Welcome and Apologies - Declarations of Interest

Apologies were received from Ian Atkinson, Lindsey Blake, Chris Cox, Alan Hassey and Mark Taylor.

### 2.1 CQC Presentation

The Chair welcomed Derek Wilkinson from the Care Quality Commission.

The item opened with a presentation on the CQC Data Security Review. Derek Wilkinson advised that the CQC Report was due to be sent to the SofS on 29<sup>th</sup> January, 2016

The Chair thanked the CQC for working closely with the Review team within the parameters set by the SofS for the NDG Review.

### 2.2 NDG Review

Katie Farrington gave an overview of the latest iteration of the NDG Report which will soon be submitted to the SofS.

Katie thanked Panel members for their hard work and input into the report. A discussion then took place on the recommendations made in the report together with items which have been amended and updated since the last Panel meeting.

## 3. GMC Guidance on Confidentiality Consultation

Fionnula Flannery, together with her colleague Alison Whiting, gave a presentation on the GMC consultation of the latest iteration of the GMC's Guidance on Confidentiality.

Fionnula advised that their Consultation period had been extended from 10<sup>th</sup> February, in view of the forthcoming publication of the National Data Guardian's Review. The Chair thanked Fionnula.

# 4. Minutes from previous meeting 30<sup>th</sup> November, 2016

### 4.2.1. EPS Update
