The certification schemes Forest Stewardship Council (FSC) and Programme for Endorsement of Forest Certification (PEFC) have been assessed and found to ensure compliance with the UK government's Legality and Sustainability criteria. FSC and PEFC are thereby accepted as Category A evidence of ensuring compliance with the government's timber procurement policy. The steps below will help you check when you receive FSC and PEFC products that the certification applies and also gives some guidance on common issues and solutions.

Step Two: Is the certificate in date and valid for the period of supply? The expiry date is listed online. Certificates are issued for five years and surveillance audits are carried out annually. Step Three: Is your supplier listed as the certificate holder? The certificate holder is listed online and should be your contractor, or additional evidence should be provided. Step Four: Are the products being supplied listed on the record for the CoC certificate? Certified suppliers supply certified and non-certified products. Only certified products are covered by the certificate scope. Step Five: Is the product supplied the product promised? Suppliers may not supply you with the certified product, even when the above steps have been carried out. Procurement records can help check this.
