Asbestos: Regulatory procedures for the movement of asbestos and any products to which asbestos has intentionally been added to. Lead department is Defra http://www.defra.gov.uk, HMRC - http://www.hmrc.gov.uk/

Animal Furs: Prevent imports of illegally culled furs. Currently covers harp and hooded baby seal products and cat and dog fur products. Prevent illegal imports from countries using leg hold traps and which have not been approved by the European Commission. Animal Pathogens: Prevent the illegal import of animal pathogens such as rabies

The role of Border Force Operational Policy team is to formulate Departmental enforcement policy and issue appropriate guidance to UK Border Force staff at the border.Lead department: The Department for Environment, Food and Rural Affairs (Defra) - http://www.defra.gov.uk/

Ammonium Nitrate: regulate large AN imports (over 500kgs).BF will detain non-certified 3rd country consignments on advice from HMRC in order for a physical examination to be undertaken by Trading standards and/or explosives experts.

Chemicals: Regulations on Chemicals which are controlled under REACH, require Prior Informed Consent (PICS), or are controlled under the Persistent Organic Pollutants (POPs). Lead department is Defra http://www.defra.gov.uk, HMRC - http://www.hmrc.gov.uk/

Commercial Plant Imports: Controls on all third country imports of plant and plant products including forestry and wood products to ensure that they comply with EU and global phytosanitary legal obligations. Convention for the International Trade in Endangered Species (CITES): Border Force is responsible for enforcement of CITES controls relating to: The import from or export to non-EU countries (whether or not via another EU Member State) of the controlled species, whether live or dead (e.g. stuffed). This includes parts or derivatives of these species such as blood, ivory, caviar, bones, teeth, furs, timber, plumage and leather goods but not animal waste products like faeces. Cultural Goods: prevent imports and exports of tainted cultural objects and enforce export licences on works of art such as paintings, sculptures, statues, furniture, archaeological pieces that have been dug out of the ground, antiques and collectors' items. Drugs: Prohibitions & Restrictions on the import and export of all controlled drugs including medicines and drugs used in sport

Drug Pre-cursor chemicals: Import and export of chemicals used to manufacture synthetic drugs or drug adulterants

Explosives: regulates imports the importation of explosives which are prohibited unless accompanied by a transfer document known as a Recipient Competent Authority (RCA) document issued by the Health and Safety Executive (HSE) and will detain pending HSE advice.

The Agency should detain any detected importation of civil use explosives not accompanied by a RCA where only a regulatory breach of the transfer controls has occurred, and should be guided by the advice of HSE before releasing the consignment. Feed and Food Imports: The Food Standard Agency (FSA) has lead policy responsibility for controls. Port health or Local Authorities will carry out all documentary, identity and physical checks. http://www.food.gov.uk/

Firearms: UK prohibitions and restrictions on imports of firearms and Realistic Imitation Firearms (RIFs) and ammunition. BIS is responsible for issuing

Fireworks: Regulatory role. Assisting HSE explosives enforcement officers, Local Authorities, Trading Standards Officers, and the Fire Service to ensure the safe storage of fireworks by providing intelligence to HSE on importers of fireworks, volume and ports of importation.

FLEGT: Forest Law Enforcement, Governance and Trade: Border Force is the enforcement authority at the border with responsibility for taking action on arrival of timber shipments with FLEGT licences from VPA (voluntary partnership agreement) countries

Forged Documents: Power to seize false identity documents smuggled into the UK (e.g. sent via post).

Genetically Modified Rice and Rice Products: The control on the import of Rice and Rice Products originating in or consigned from China. There are special conditions on the import of these products. Offensive Weapons: UK prohibition on importation of flick and gravity under the Restriction of Offensive Weapons Act and prohibition and restrictions in place against designated weapons listed in the Offensive Weapons Order under the Criminal Justice Act.

Ozone Depleting Substances:

The purpose of these controls is to prevent the illicit import and export of ozone depleting substances and goods which contain them, into and out of the European Union (EU). UK Border Force can detain the consignment on behalf of the Department for Environment, Food & Rural Affairs (Defra), Lead Department - The Department for Environment, Food and Rural Affairs Defra http://www.defra.gov.uk

Plastic Kitchenware: Controls on the Imports of plastic kitchenware originating in or consigned from China and Hong Kong. Lead Policy Department is -The Food Standards Agency (FSA) - http://www.food.gov.uk/

Products of Animal Origin: regulate commercial imports; prevent illegal commercial and personal imports, ensure delivery of POAO awareness raising programme.
