Thank you for your email dated 9 June 2015 requesting information on the HCA Property Framework 2014-2018. For ease of reference we have answered each of your questions in turn, below:

***Under the Freedom of Information Act 2000 I seek information about the 2014 Framework Agreement for property-related professional and technical services.***

***I would be grateful if you could please confirm:***

***a) the start and end date of this Framework Agreement***

This Framework runs from 18 June 2014 – 17 June 2018.

***b) the total estimated value of this Framework Agreement***

We have listed this Framework in the Office Journal of the European Union as being in the range of £40,000,000 - £100,000,000 for the duration of the Framework.

***c) the total expenditure thus far in these contracts***

As of 9 June 2015, the total expenditure thus far is £13,973,152.85. This consists of £5,024,512.05 spend by the Homes and Communities Agency and £8,948,640.80 by other public bodies.

***d) whether there are any options for extension***

There are no options for extending this Framework panel.

***e) the full description of the services being provided by Capita under these contracts***

Please see the document attached alongside this letter, which details the full description of services in this Framework.

***f) the lots that Capita have been awarded in the Framework Agreement***

We can confirm there are no lots, there is solely the one Framework.
