Thank you for your email of 20 January 2016 requesting the following information:

'I would like to enquire whether you hold data relating to rescues from salt marsh and mudflats in Essex by (MCA and/or MOD) over the last 5 or 10 years?

If so, please could advise me how to obtain a copy?'

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

Although details on location are held, MOD does not hold data on Search and Rescue (SAR) callouts by ecosystem. Crews do have the ability to record observations on callouts in which they can reference the type of area in which the callout occurred. We have therefore searched this data to locate all callouts that have occurred within Essex in the last 10 years that reference 'mud flat', 'mudflat' or 'marsh' and have attached details of the callouts including latitude and longitude data. We have broadened the search phrase 'salt marsh' to 'marsh' as crews are less likely to record the stricter term 'salt marsh' in their reports. These numbers should be considered a minimum as crews may not have recorded the ground conditions where operations took place. Callouts in Essex were identified by latitude and longitude data provided by the crews. Although Southend-on-Sea is an independent Unitary Authority area with borough status we have included it as a separate piece of analysis as it is still included within the ceremonial county of Essex.

To note, the data underpinning this analysis has been produced from that provided by the Aeronautical Rescue Coordination Centre (ARCC) and includes all military SAR units, both helicopter and Mountain Rescue Teams (MRT) that operated in the UK during the last 10 years. As part of the transfer of SAR functions to a civilian contract controlled by the Department for Transport (DfT), military SAR units were drawn down throughout 2015 as civilian units replaced them.

MOD does not have access to the records for the Maritime Coastguard Authority (MCA). Any requests for MCA data should be addressed to:

Narrative details have been redacted to remove personal details; the details of each callout remain to help identify the type of action that occurred.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still

dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail <u>CIO-FOI-IR@mod.uk</u>). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
