Public Path Diversion Order 2015

This Order is made by Surrey County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the public and the landowner, it is expedient that the lines of Public Bridleway No.74 & Public Footpath No.76 (Esher) should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Surrey County Council definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of highways shown or required to be shown in the map and statement.

The Elmbridge Borough Council have been consulted to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:-

- THE public rights of way over the land situated at Pondtail Farm, Chilbrook Road, Downside, Cobham; and shown by bold continuous lines on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up at the date on which it is certified by the Authority that the public paths described in Part 2 of the Schedule to this order are in a fit condition for public use and thereupon the Surrey County Council definitive map shall be modified by deleting from it those public rights of way.
- THERE shall be at the date on which it is certified by the Authority that the public paths described in Part 2 of the Schedule to this Order are in a fit condition for public use, a public bridleway shown by bold dashes with bars in the intervals and a public footpath shown by a bold broken line over the land situated at Pondtail Farm, Chilbrook Road, Downside, Cobham as described in Part 2 of the Schedule and on the map contained in this Order, and thereupon the Surrey County Council definitive map shall be modified by adding those paths to it.

2A THE Surrey County Council definitive statement shall be modified as described in Part 4 of the Schedule to this order.

Part 1 Description of site of existing path or way

Public Bridleway No.74 (Esher) from point 'A' 5 metres to the west of its junction with Public Footpath No.76 (Esher), in a generally westerly direction for 180 metres to point 'D', as shown on Drawing No. 3/1/77/H18F.

Public Footpath No.76 (Esher) from point 'E' at its junction with Public Bridleway No.74 (Esher), in a southerly direction for 230 metres to point 'H' at its junction with Public Footpath No.75 (Esher), as shown on Drawing No. 3/1/77/H18F.

Part 2 Description of site of new path or way

Public Bridleway No.74 (Esher) from point 'A' at a point approximately 220 metres from its junction with Chilbrook Road, in a southerly direction for 10 metres to a culvert at point 'B', then continuing in a southerly direction for a further 47 metres to point 'C', then in a westerly direction for 145 metres to point 'D' as shown as a bold dashes with bars in the intervals on Drawing No. 3/1/77/H18F. The Bridleway to have a width of 3 metres except from where it crosses the culvert where the width will be 2m.

Public Footpath No.76 (Esher) from point 'C' at its junction with Public Bridleway No.74 (Esher), in a southerly direction for 155 metres to point 'F', then in an easterly direction for 10 metres to point 'G', then in a southerly direction for 17 metres to point 'H' as shown by a bold broken line on Drawing No. 3/1/77/H18F. The footpath to have a width of 2 metres.
