Data item (100536) <SENprovision > and codeset D00229 are used in School Census, Early Years Census and Alternative Provision Census. If this RFC is approved a new data item will be introduced to replace (100536) with a new CBDS number referring to the new codeset, all other metadata will remain the unchanged.

Reason for change (including benefits):

The 2014 SEND <u>code of practice</u> removed the requirement for separate 'school action or early years action' and 'school action plus or early years action plus' categories – these were replaced by a single 'SEN support' category (code 'K'). <u>The Children and Families Act 2014</u> replaced 'SEN statements' with 'Education, Health and Care plans' (EHC plans). The exception is where a child has and existing statement and has not completed a transfer review to an EHC plan, in which case the 2001 code continues to apply.

Please note: Codes A and P will remain valid in the school census until spring 2016 for the recording of SEN provision at time of exclusion only.
