NDA Designation of Winfrith (Modification and Revocation Direction No. 1)

Presented to Parliament by the Secretary of State for Energy and Climate Change pursuant to sections 3 and 5 of the Energy Act 2004.

WINFRITH SITE INTRODUCTION AND SUMMARY

This introduction and summary is not part of the Direction.

The Secretary of State, in exercise of the powers conferred upon him by section 3 of the Energy Act 2004 (the "2004 Act"), made directions on 3 December 2004 giving the NDA responsibilities in relation to certain nuclear sites.

The Secretary of State designated the Winfrith Nuclear Site for the purposes of section 3 of the 2004 Act in a direction which came into force on 1 April 2005 (the "NDA Designation of Winfrith").

The person with control of the Winfrith Nuclear Site is Research Sites Restoration Limited, which has consented to this Direction.

This Direction modifies the area of land defined as the principal nuclear site in Schedule 1 of the NDA Designation of Winfrith as a result of certain areas of land meeting the requirements of the Site End State set out for the Winfrith principal nuclear site in the NDA Strategy. For completeness, this Direction also revokes the NDA Designation of Winfrith in relation to those areas of land.

1. Citation and Interpretation

- (1) This Direction may be cited as the NDA Designation of Winfrith (Modification and Revocation Direction No. 1).
- (2) In this Direction
 - a) "2004 Act" means the Energy Act 2004 and references to sections are to sections of that Act;
 - b) "NDA Designation of Winfrith" means the NDA designating direction for Winfrith which was made on 3 December 2004 and came into force on 1 April 2005.
- (3) Where the context permits, words and expressions used in this Direction that are defined or used in the NDA Designation of Winfrith have the same meaning as in that direction.

2. Direction

Under sections 3 and 5 of the 2004 Act, the Secretary of State gives the NDA this Direction for the purposes set out in paragraph 3 below.

3. Modification and Partial Revocation of the NDA Designation of Winfrith

- (1) The NDA Designation of Winfrith is modified as follows
 - a) In Schedule 1, in column 3 (Description) of the first row (No 1), for "Land situated at Winfrith in the District of Purbeck in the County of Dorset, shown outlined in blue on drawing referenced GIS-04-06-038 Issue 2, dated 02/06/2004 and entitled "Map of Winfrith showing the Principal Nuclear Site", Nuclear Site Licence Number 47 Annex "A"", substitute "Land situated at Winfrith in the District of Purbeck in the County of Dorset, shown shaded blue on drawing referenced 05_1188, Issue 8, dated 17.03.2014 and entitled "Winfrith Site Estate Plan" Annex "A""; and
 - b) For Annex A of the NDA Designation of Winfrith substitute Annex A contained in the Schedule of this Direction.
- (2) The NDA Designation of Winfrith is revoked in relation to any land which, by virtue of sub-paragraph (1) of this paragraph, no longer falls within the land previously described as the principal nuclear site in accordance with Schedule 1 and Annex A of the NDA Designation of Winfrith.
