We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

“Please give me a description of any reported or recorded offences with regards to distraction while driving in the past 24 months. Specifically I would like to know:

- 1. The time and date of the offence.**
- 2. The location.**
- 3. The type, make and model of the vehicle.**
- 4. A description of the distraction**
- 5. The police response (ie. caution, arrest, fine etc).**
- 6. The gender and age of the driver.**
- 7. Please provide any pictures or video of the offence if you have them”**

A search for information has now been completed and I can confirm some information in scope of your request is held by the Ministry of Defence Police.

If you are not satisfied with this response or wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, London SW1A 2HB (email CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate the case until the MOD internal review process has been completed.
