NORFOLK COUNTY COUNCIL (HOLT)

MODIFICATION ORDER 2015

This Order is made by Norfolk County Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that the Definitive Map and Statement of Public Rights of Way for the County of Norfolk ("the Definitive Map and Statement") require modification in consequence of an event specified in Section 53(3)(c)(i) of the Act, namely:-

- (a) Section 53(3)(c)(i) - the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path or a restricted byway.

The Authority have consulted with every local authority whose area includes the land to which the Order relates.

The Norfolk County Council hereby order that:-

1. For the purposes of this Order the relevant date is 1 August 2015
2. The Definitive Map and Statement of Public Rights of Way for the County of Norfolk shall be modified as described in Part I and Part II of the Schedule and shown on the map contained in this Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Norfolk County Council (Holt) Modification Order 2015.

SCHEDULE

PART I

Modification of the Definitive Map

Description of path or way to be added

Restricted Byway (Thornage Road/Riverside Road to field boundary) Starts at the junction of the U14421 Thornage Road and U14421 Riverside Road, Thornage at map reference TG0609 3833 (point A as shown on the map contained in this Order) and runs in a south westerly direction for a distance of 174 metres to map reference TG0599 3819 (point B as shown on the map contained in this Order) and then runs in a southerly direction for 290 metres where it terminates at a field boundary at map reference TG0597 3790 (point C as shown on the map contained in this Order). The width of the route lies between boundary features and varies between 4 metres and 6.5 metres with a usable width varying between 2.5 metres and 3.5 metres (as shown on the map contained in this Order). The length of the route is approximately 464 metres.

PART II

Modification of Definitive Statement

Restricted Byway (Thornage Road/Riverside Road to field boundary) Starts at the junction of the U14421 Thornage Road and U14421 Riverside Road, Thornage at map reference TG0609 3833 and runs in a south westerly direction for a distance of 174 metres to map reference TG0599 3819 and then runs in a southerly direction for 290 metres where it terminates at a field boundary at map reference TG0597 3790.
