**The A1(M) Motorway (Junction 17 Fletton Parkway, City of
Peterborough) Northbound
(Temporary Restriction and Prohibition of Traffic) Order 2014**

Made - - - - - *3rd February 2014*
Coming into force - - - - - *10th February 2014*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A1(M) Motorway (“the A1(M)”) and connecting roads, is satisfied that traffic on a length of that road and on one of those connecting roads in the City of Peterborough should be restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) and regulation 16(2) of the Motorway Traffic (England and Wales) Regulations 1982(b) hereby makes the following Order:-

1. This Order may be cited as the A1(M) Motorway (Junction 17 Fletton Parkway, City of Peterborough) Northbound (Temporary Restriction and Prohibition of Traffic) Order 2014 and shall come into force on 10th February 2014.

2. In this Order:

“the tip of the nosing” means, as indicated by the markings on the carriageway, the first point where an entry slip road joins, or the last point where an exit slip road leaves, the carriageway of the motorway;

“the motorway” means the northbound carriageway of the A1(M) from the centre point of Haddon Road underpass to a point 125 metres north of the tip of the nosing of the exit slip road at Junction 17;

“the first length of link road” means the road that links the exit slip road from the northbound carriageway of the A1(M) at Junction 17 to the A1139 Fletton Parkway, from the tip of the nosing of the exit slip road from the A1(M) at Junction 17 to its merge with the A1139 Fletton Parkway;

“the second length of link road” means the road that links the exit slip road from the northbound carriageway of the A1(M) at Junction 17 to the A1139 Fletton Parkway, from

its diverge with the exit slip road to the A605 Fletton Parkway roundabout to its merge with the A1139 Fletton Parkway;

“a works period” means a period of 10 hours starting at 20:00 hours on Monday 17th February 2014 or on any subsequent day until the works have been completed;

“the works period” means the period starting at 20:00 hours on Monday 17th February 2014 and ending when the works have been completed;

“works” mean Local Authority road widening and improvement works being carried out on the A1139 and road construction, resurfacing, road markings, traffic signs installation, road lighting, drainage, road restraint system and enforcement camera installation works on the link road;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour on the motorway or the first length of link road.

4. Subject as mentioned in article 5 no person shall, during a works period, cause or permit any vehicle to enter or proceed in the second length of link road.

5. The provisions of articles 3 and 4 shall not apply to a vehicle –

- (a) being used in connection with the works or for traffic officer or winter maintenance purposes,
- (b) being used for police, fire and rescue authority or ambulance purposes, or
- (c) proceeding at the direction, or with the permission, of a constable, or a traffic officer in uniform;

and nothing in article 3 shall apply to a vehicle being used for a purpose specified in paragraph (b) of this article or to a vehicle falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

6. During a works period, the provisions of Regulations 5 and (in so far as it relates to a vehicle being driven) 9 of the Motorways Traffic (England and Wales) Regulation 1982 are hereby suspended in relation to the hard shoulder adjacent to the second length of link road at such times and to such extent as may be indicated by traffic signs; and in this article “hard shoulder” has the meaning given in regulation 3(1)(e) of those Regulations.

THE A1(M) MOTORWAY (JUNCTION 17 FLETTON PARKWAY, CITY OF
PETERBOROUGH) NORTHBOUND (TEMPORARY RESTRICTION AND
PROHIBITION OF TRAFFIC) ORDER 2014**

NOTICE IS HEREBY GIVEN that the Secretary of State for Transport has made an Order on the A1(M) Motorway in Peterborough to enable local authority road widening and improvement works on the A1139 and associated works on the link road to be carried out in safety.

The works are expected to start at 8am on Monday 17 February 2014 and will continue until 15 February 2015.

The effect of the Order on the A1(M) will be to –

1. impose, for 24 hours daily, a 50 miles per hour speed limit on the –
 - 1.1 northbound carriageway from the centre point of Haddon Road underpass to 125 metres north of the exit slip road at J17, and
 - 1.2 northbound link road from the exit slip road at J17 to the A1139 Fletton Parkway, and
2. close the northbound link road from the exit slip road at J17 to the A1139 Fletton Parkway, from its diverge with the exit slip road to the A605 Fletton Parkway roundabout to its merge with the A1139 Fletton Parkway, diverting traffic to the A605 Fletton Parkway roundabout to join the A1139, and
3. allow hard shoulder running, in conjunction with a lane closure on the length described at 2 above for 24 hours daily.

The speed limit (which will not apply to emergency service or special forces vehicles), closure (which will not apply to works, emergency service, traffic officer or winter maintenance vehicles) and diversion route will be clearly indicated by traffic signs throughout the works.

The Order will come into force on 10 February 2014 and have a maximum duration of eighteen months.

Coming into force - - - - - *29th August 2014*

The Secretary of State for Transport makes the following Order in exercise of the powers conferred by section 14(1)(a) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984(a): -

1. This Order may be cited as the A1(M) Motorway (Junction 17 Fletton Parkway, City of Peterborough) Northbound (Temporary Restriction and Prohibition of Traffic) Variation Order 2014 and shall come into force on 29th August 2014.

2. The A1(M) Motorway (Junction 17 Fletton Parkway, City of Peterborough) Northbound (Temporary Restriction and Prohibition of Traffic) Order 2014(b) is hereby varied by substituting, for the definition of "a works period" in article 2, the following definition -

"a works period" means a period of -

- (a) 10 hours starting at 20:00 hours on Monday 17th February 2014 or on any subsequent day, other than a Friday or a Saturday, and
- (b) 12 hours starting at 20:00 hours on Friday 29th August 2014 or on any subsequent Friday or Saturday,

until the works have been completed;
