

Application for Authorisation of Establishments to Export Fish and Shellfish Products to the People's Republic of China

Guidance for completion

- Please complete application electronically. Incomplete application will not be processed;
- Authorisation is required to export fish and shellfish products (other than live) for human consumption to the People's Republic of China where use of 7208EHC is applicable;
- 7208EHC must be certified by an Environmental Health Officer (EHO) of the Local Authority or an Official Veterinarian (OV);
- A register of EHOs/OVs authorised to certify 7208EHC must be maintained and made available to the Chinese authorities upon request;
- Parts 1 and 2 of this application must be completed by the exporter and Part 3 must be completed by the EHO(s)/OV(s);
- To amend Part 3 Signature and Stamp Register details, a new application must be submitted. Amended Part 3 Register application details must contain all signatures and stamps of EHOs/OVs who may certify consignments. Amended Part 3 Register applications will revoke and replace previously submitted applications;
- Where indicated, Part 3 Register details must be completed in typescript. Additional pages may be used as required;
