B.1 Enhanced Impact Assessment

- 1. Section 9 of the Academies Act 2010 (later as amended by the Education Act 2011) places a duty on the Secretary of State to take into account what the impact of establishing the institution would likely be on maintained schools, Academies, institutions within the further education sector and alternative provision in the area in which the institution is (or is proposed to be) situated. Any adverse impact will need to be balanced against the benefits of establishing the new school.
- 2. We have carried out an Impact Assessment (see Annex B1) which concludes that the impact on most local schools and colleges should be minimal to moderate. One school, Basildon Upper Academy, have been assessed as high impact but there are mitigating factors that would reduce this to moderate.
- 3. Basildon Upper Academy is a 14-19 school specialising in maths and enterprise. The capacity is 1400, but currently has 794 students on the academy roll, with 162 in its sixth form. Attainment is well below the national average at 45% 5A*C inc EM . Basildon Upper Academy was put into special measures in March 2012.
- 4. On 25-26 April, Ofsted conducted their third monitoring visit and the inspector said that the Academy is making reasonable progress towards the removal of special measures. This is evidenced by improved GCSE results from

- 31%5A*C inc EM in 2010 to 45% last year. It is therefore expected that education standards will continue to improve and thus make the schools more attractive.
- 5. Whilst a loss of even a few pupils could exacerbate the existing surplus issue in Basildon Upper Academy the unique provision offered by the Studio School and its specialism (Health and Sport) which is sufficiently different to the Basildon Upper Academy's specialisms will be a mitigating factor against having an unduly adverse impact on any one school. The Studio School is small (at steady state admitting 180 Yr 10 and 144 Yr 12 students). With its unique curriculum it will also offer parents and students greater choice.
- 6. Essex LA's response to the statutory consultation was very positive and 'welcomed the diversity of education opportunity that the studio school will provide' adding that the school will 'allow a positive impact to be made locally and help raise both engagement and standards. The LA believe to see growth of more than 250 additional students in the secondary phase over the next five years. This is supported by our own secondary school population figures and it is therefore, possible that any negative impact will be mitigated by an increased demand for secondary school places in the local area as the secondary school aged population is projected to remain relatively stable over the next few years. Official also wrote to Thurrock Council who consulted their maintained schools and Academies and expressed no objections.
- 7. There are three colleges Seevic College, Palmer's College and Havering Sixth Form College within five miles of the Studio School, all of which are likely to feel a minimal impact.
- 8. We conclude that it is appropriate for the Secretary of State to enter into a Funding Agreement with the Trust in light of the possible impacts on the basis that:
 - a. The school will be likely to improve standards in the area;
 - b. The school will give parents greater choice and will offer something different to existing schools. It will offer a unique curriculum model, provide work experience opportunities for students and offer an extended school day with a more "business-like" ethos.

Summary of Statutory Section 10 Consultation

The Academy Trust of the Studio School carried out a consultation that ran from 29th October to 14th December. 73 responses were received. 67 respondents answered yes when asked 'they support the principles of the New Campus Basildon Studio School. When asked if 'the Academy Trust should enter into a funding agreement with the Secretary of State in relation to a Studio School' 50 respondents answered yes. The respondents who answered indicated concern 'that difficult young people will be recommended for this school causing other students to be left out of this opportunity'. The low proportion of negative respondents, compared to positive comments leads us to conclude that the consultation does not suggest it would be inappropriate to enter into a Funding Agreement.

Conclusion

With its Basildon district catchment area, NCB Studio School will operate across a region of approximately 19,242 places. As a result, the effect of the studio school on schools in this area is likely to be spread across a large number of institutions. This would reduce the impact of the studio school on individual schools, and their ability to improve or remain viable. For colleges that also deliver courses to pupils outside the studio school's age range, the effect of the studio school would be further reduced. As a result, this assessment concludes that, in terms of the possible impact of the proposed studio school, it is appropriate for the Secretary of State to enter into a Funding Agreement with the Academy Trust of New Campus Basildon Studio School.
