

# PROPOSED MODIFICATIONS

## NORTH YORKSHIRE COUNTY COUNCIL

### WILDLIFE AND COUNTRYSIDE ACT 1981

#### THE EASTERN PART OF THE COUNTY OF THE FORMER NORTH RIDING OF YORKSHIRE DEFINITIVE MAP AND STATEMENT

#### PUBLIC FOOTPATH 25.85/43 SHERIFF HUTTON AND PUBLIC FOOTPATH 25.85/44 SHERIFF HUTTON MODIFICATION ORDER 2011

This Order is made by North Yorkshire County Council under Section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Eastern Part of the County of the former North Riding of Yorkshire Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act, namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to Section 54A, a byway open to all traffic.

The authority have consulted with every local authority whose area includes the land to which the Order relates. North Yorkshire County Council hereby order that:-

1. For the purposes of this Order the relevant date is 30 September 2011.
2. The Eastern Part of the County of the former North Riding of Yorkshire Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as "Public Footpath 25.85/43 Sheriff Hutton and Public Footpath 25.85/44 Sheriff Hutton Modification Order 2011".

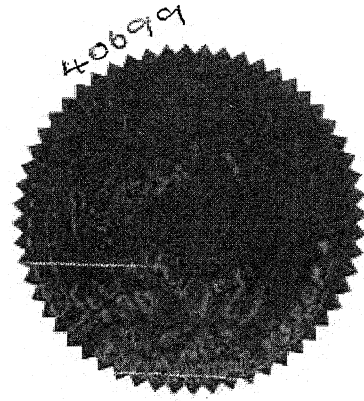

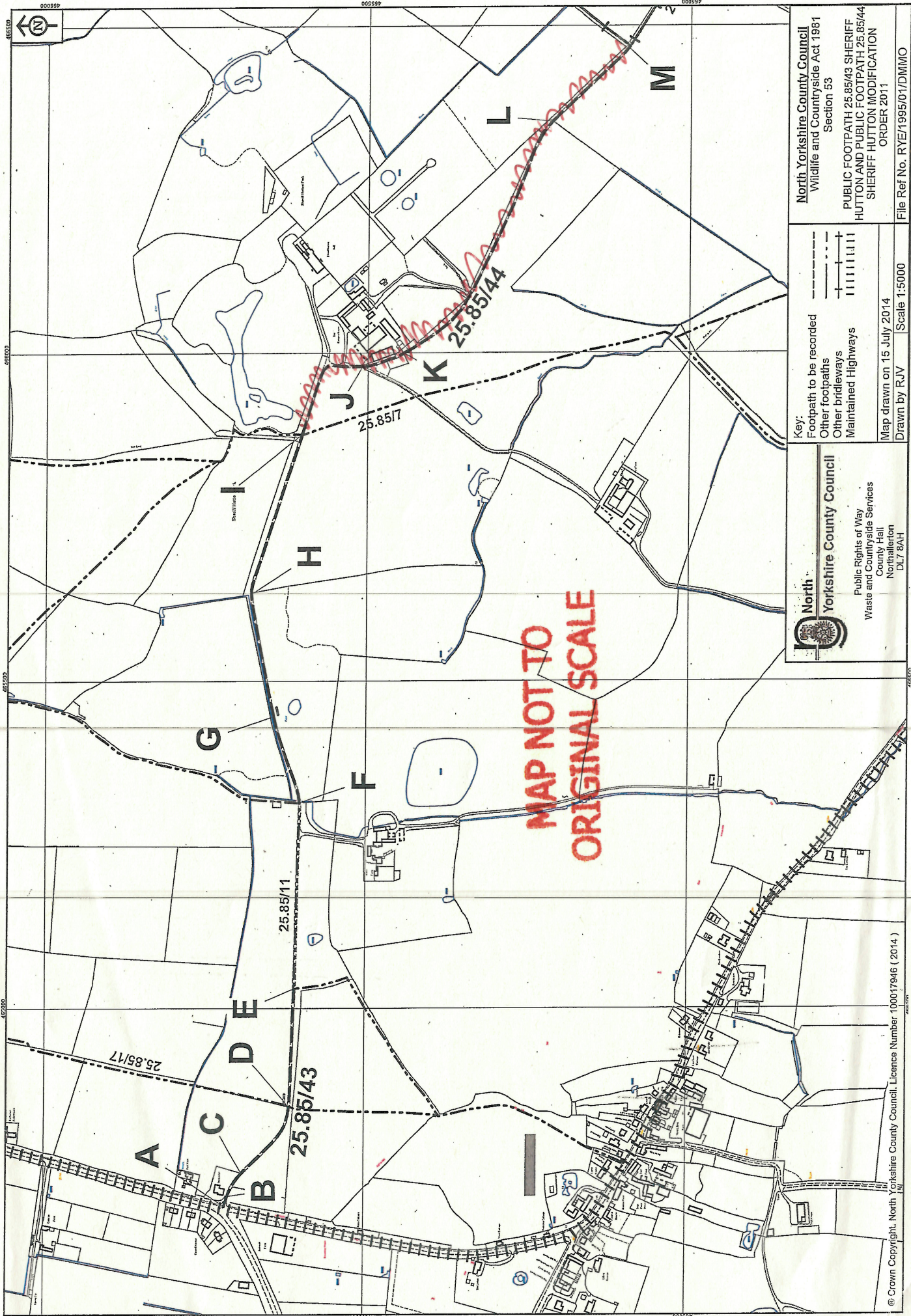
