Thank you for your email of 20 July 2015 where you requested:

...how much money the MoD pays to Help for Heroes each year in relation to the defence recovery capability. I would like a breakdown of payments annually from 2010 in terms of what services the MoD is paying for

I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held. The information you requested is below. The only money the MOD pays to Help for Heroes is for food and accommodation for Tedworth House and Phoenix House. The breakdown from FY11/12 to Q1 FY15/16 is in the table below:

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
