

2015 DUTY PROVIDER CRIME CONTRACT - CONTRACT FOR SIGNATURE

This Contract is made on the date on which the Provider (defined below) executes it in accordance with the requirements of Clause 7 (Execution)

Between:

- (1) The Lord Chancellor whose head office is situated at *102 Petty France, London, SW1H 9AJ* ("we/us/our"); and

BACKGROUND

- (A) On 27 November we published our invitation to tender for Contract Work.
- (B) You submitted a tender in respect of our invitation to tender.
- (C) Following our evaluation of your tender, we wish to appoint you to provide Contract Work in the Classes of Work specified in your Schedule and you are willing to provide the same and to accept such appointment on the terms and conditions of the Contract.

1. Definitions and order of precedence

- 1.1 The expression "Standard Terms" shall mean the Standard Terms of the 2015 Duty Provider Crime Contract. Words and expressions defined in the Standard Terms shall have the same meaning when used in this Contract for Signature subject to Clause 1.2.
- 1.2 For the avoidance of doubt, in the event of any conflict between the provisions of this Contract for Signature and the Standard Terms (or any of the other Contract Documents) the provisions of this Contract for Signature shall prevail as further provided in Clause 12.1 of the Standard Terms (Contract Documents and precedence).

2. Contract Period

- 2.1 The Contract Start Date shall be [date] and the Service Commencement Date shall be 11 January 2016. The Contract Period shall be the period of four years commencing on the Service Commencement Date.
- 2.2 The Contract shall commence on the Contract Start Date and will, subject to extension in accordance with Clause 2.3 of this Contract for Signature and/or early termination in accordance with the terms of the Contract (including this Clause 2), expire at the end of the Contract Period.
- 2.3 We may extend the Contract Period on any number of occasions and for any period provided that:
- (a) the minimum period of any such extension is three months; and
 - (b) the aggregate duration of all extensions to the Contract Period pursuant to this Clause 2.3 may not exceed one year.
- 2.4 To extend the Contract Period pursuant to Clause 2.3 above, we must give you at least three months' (in the case of the first extension) or one month's (in the case of any subsequent extension), notice before the expiration of the then current Contract Period.
