1. The Secretary of State welcomed attendees to the meeting – the first since the General Election - and asked Board members to introduce themselves.

# **Item 1: Secretary of State Priorities**

2. The Secretary of State set out his priorities for the Department, with a particular focus on delivering the Government's commitments on housing and devolution to cities and local government. The Government would set a fast pace in order to achieve its commitments over the life of the Parliament.

- 4. Sara Weller gave a short explanation of the previous work of the Board, noting the Board's role in testing and scrutinising the implementation of key policies and programmes. She noted that external experts were often invited to bring a fresh input to discussion.

  - a. to continue with the same frequency and format of meetings meeting five times a year
  - b. the October meeting would discuss Housing and the December meeting would cover Decentralisation
  - c. A short paper to stimulate discussion would be produced for each meeting.
