

## **Countryside and Rights of Way (CROW) Act 2000:**

### **PROPOSAL FOR A LONG TERM DIRECTION BY THE RELEVANT AUTHORITY**

#### **SUMMARY FOR PUBLIC CONSULTATION Prepared by Forestry Commission**

#### **1. INFORMATION ABOUT THE PUBLIC CONSULTATION**

The Forestry Commission has received an application under section 25 (1b) of the Countryside and Rights of Way Act (the Act) for a direction to exclude the public from the site indicated on the attached map, in order to carry out timber harvesting operations.

Having considered the application, the Forestry Commission now proposes to give a direction on the site that may last for longer than 6 months continuously. The direction proposed is for a closure of a maximum of 220 days to be used between 01 January 2016 and 21 December 2020. The Act requires us to consult publicly on all such proposals for 'long-term directions'.

This is a summary of our proposal, explaining the reasoning in support of our proposal. It is accompanied by a map of the site which will be available on the Open Access website from 27 November 2015:

## **2. SUMMARY OF RELEVANT AUTHORITY PROPOSAL**

### **i) Summary of proposed direction to restrict access**

Long term outline direction for a closure of a maximum of 220 days to be used between 01 January 2016 and the 21 December 2020, for the purpose of clearfell of conifer by harvester/forwarder over 42ha.

### **ii) Why is a statutory restriction necessary?**

Public Safety

### **iii) What is lowest level of restriction required?**

Full Exclusion of Public access

## **ADDITIONAL INFORMATION TO SUPPORT THE APPLICATION FOR OUTLINE DIRECTION OF LONG TERM CLOSURE**

The proposed Felling Coupe is forecasted to produce 21118m<sup>3</sup> of timber to supply local markets. The site covers an area of 42 Hectares (gross area).

At this stage of the operational planning process the site will be worked during the period of January 2016 to December 2020. The operation on the site will be carried out utilising approved and standard timber harvesting techniques, i.e. harvester / forwarder. Given normal rate of production (500m<sup>3</sup> per week) and the likelihood that one harvester and one forwarder will work the site, it will take at least 220 days to complete the operation.

Due to the hazardous nature of timber harvesting operations, as Forestry Works Manager, I have a responsibility to consider the risks to members of public under Health & Safety legislation. With reference to current industry best practice which is outlined in the FASTCO publication, "Managing Public Safety in Harvesting Sites", exclusion of members of the public is one of a range of recommended control measures.

Further control measures include the use of warning and prohibition signs placed at the forest road access points. Two forest roads serves Moneyrees harvesting site, signage (including CROW exclusion maps) will be placed at the point where forest road meets the site boundary.

To maintain operational flexibility it is unfeasible to split the site into smaller units.

I need to be in a position to respond immediately to shifts in the market and weather by moving production from part of the site to another.
