**Report on:** Provider Appraisal Update

#### **Provider Appraisal directorate headlines:**

1. The Provider Appraisal directorate currently has two active assessments and one new trust was referred this month. There are four ongoing transaction reviews.

2. There are no policy or strategy issues to report to the Board.

#### A. Developments

3. The Executive Director of Provider Appraisal has met with the NHS Trust Development Authority (NHS TDA) to discuss developing trusts against the Well Led framework. The aim is to identify ways in which development and assessment of trusts can be streamlined. In light of recent announcements regarding closer working between Monitor and the NHS TDA, the team will be engaging with the NHS TDA to maximise the benefits to patients.

#### B. Update on assessments

Active assessments (exception reporting)

- 4. A list of the 12 NHS trusts currently with Monitor for assessment is provided in Annex 1. Any changes from the last report are highlighted in red.
- 5. At the Provider Appraisal Executive (PAE) meeting on 17 June 2015, the decision was made to defer the assessment of Dudley and Walsall Mental Health Partnership NHS Trust for up to 12 months (potentially up to 24 June 2016).

#### Referrals

6. The assessments of Wirral Community NHS Trust and Norfolk Community NHS Trust will commence on 1 August 2015. One new referral has been received (Lincolnshire Community Health Services NHS Trust) this month.

#### Assessment Pipeline

7. An overview of the assessment pipeline is provided in Annex 2.

### C. Update on transactions

Cambridgeshire integrated and older persons care joint venture

8. The Provider Appraisal directorate is nearing the completion of the transaction review of the Cambridgeshire and Peterborough NHS Foundation Trust (CPFT) older persons transaction. As agreed by the PAE in March 2015, this has been undertaken under the regulatory remit of a formal investigation into CPFT finances given that the transaction progressed on 1 April 2015 following an amber risk rating at that time.

South Devon Healthcare NHS Foundation Trust FBC review

9. A discussion on a risk rating is planned for the PAE meeting on 7 August 2015.

Chelsea and Westminster NHS Foundation Trust acquisition of West Middlesex University Hospital

10. A Board to Board meeting was held with the Trust on 25 June 2015. The team is planning to issue a transaction risk rating following the PAE meeting on 7 August 2015.

#### Making a difference for patients:

Monitor's mission is to make the health sector work better for patients. This report provides an update on the Provider Appraisal team. The key focus of this team is to assess if providers are well led and can therefore deliver sustainable high quality services to patients.

#### **Public Sector Equality Duty:**

It is not considered that there are any decisions within this paper which would impact on protected groups Identified by the Act.

The information is exempt as it falls under section 36 of the Freedom of Information Act 2000.
