Thank you for your email of 4 January 2016 which requested the following information:-

For each month between October and December 2015, and broken down between Iraq and Syria,

- 1. The number of a) Reaper b) Tornado, c) Typhoon missions flown;*
- 2. The number of a) Reaper b) Tornado c) Typhoon sorties with weapons released;*
- 3. The number and type for weapons released by a) Reapers, b) Tornado, c) Typhoon*
- 4. The number of UK air strikes in Iraq and Syria per month from 1st October 2015 and 31st December broken down between Reaper, Tornado and Typhoon aircraft?*
- 5. If UK armed forces have utilised US unmanned aircraft since 1st October and, if so, the number of sorties/ weapons releases?*
- 6. A monthly breakdown of number of airstrikes carried out by a) Reaper b) Tornado and c) Typhoons using the UK method rather than the Coalition method since 1 October 2015.*

Your correspondence has been treated as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and we can confirm that some information in scope of your request is held.

The information requested, covering from 1 October to 31 December 2015, can be found below:

1. For this question alone, missions that have flown in Syrian airspace have also flown in Iraq, therefore the missions have been included in both columns making the Syrian missions a subset of the Iraq missions.

Regarding your fifth question, the UK Reaper Force has not flown any US Air Force aircraft in support of operations in Iraq and Syria in the period in question.

As per the written statement provided to the House by the Secretary of State for Defence on 16 July 2015, we are to use Coalition produced numbers for UK strikes. As such, we have ceased to produce strike data using the UK method and the information you requested on airstrikes from 1 October 2015 is not held. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
