FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: NUMBER AND CRIME TYPE OF OFFENCES THAT RESULTED IN CAUTIONS.

I refer to your email dated 11th November 2016.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email of the 11th November 2016 you requested the following information:

"The number of offences that resulted in cautions (including warnings and reprimands) in each of the last five years (in financial years ideally, or however they are collated, with 2015 or 2015/16 included).

Please break down each annual figure into crime types, for instance murder/rape/burglary theft.

Also, for each crime type, please break down this figure into 1. cautions for adults and 2. warnings and reprimands for juveniles."

A search for information has now been completed and I can confirm that information in scope of your request is held.

Please see table at Annex A attached.

If you are not satisfied with this response or wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, London SW1A 2HB (email <u>CIO-FOI-IR@mod.uk</u>). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate the case until the MOD internal review process has been completed.
