M4 junctions 3 to 12 smart motorway Statement of Community Consultation

The Highways Agency is inviting your feedback on its planned scheme to improve the M4 motorway (M4) between junctions 3 and 12 to a smart motorway (the scheme). The purpose of this Statement of Community Consultation (SoCC) is to set out how it will consult the local community about its proposals. This SoCC provides details of where further information can be obtained or viewed and how comments on the proposals can be made. The document also provides background to the Scheme and how the application to build it will progress.

The application

The Highways Agency is promoting the Scheme under the Planning Act 2008 (the Act) and is publishing this SoCC under Section 47 of the Act.

The Scheme is a Nationally Significant Infrastructure Project (NSIP). Therefore the Highways Agency is required to make an application to the Secretary of State for a Development Consent Order (DCO) to build and operate the Scheme.

The Highways Agency anticipates that a DCO application for the scheme will be submitted to the Secretary of State in early 2015.

The scheme

The M4 is the main strategic route between London and the West of England and Wales. It provides direct access to the M25 and Heathrow Airport. The M4 from junction 3 (Hayes) to junction 12 (Theale) is approximately 32 miles long and carries over 130,000 vehicles per day. It currently suffers from heavy congestion, and unpredictable journey times. Traffic on the M4 is expected to increase significantly over the next 20 years and without improvements to the route, this will result in further congestion.

This Scheme will upgrade the M4 to a smart motorway

- Relieve congestion and smooth the flow of traffic
- · Improve journey times and journey time reliability
- · Support economic development and facilitate economic growth within the region
- · Minimise the effect of the scheme on the environment

The key changes that you will see on the M4 are:

- · Hard shoulder will be permanently converted to a running lane
- Provision of emergency refuge areas
- · Signs and signals providing information about speed limits, travel conditions and any lane closures
- · The replacement and adjustment of some bridges
- · Some compulsory aquisition of land will be required to complete this work, however no demolition of residential properties is required.

Smart motorways typically have a lower environmental impact than traditional motorway widening schemes as there is less physical work. This minimises the potential impact on watercourses, habitats and landscapes. Additionally, the technology used for smart motorways allows traffic flows to be regulated; reducing congestion.

Because of its size and potential impacts, the scheme falls within the scope of the environmental impact assessment directive, meaning that an environmental impact assessment (EIA) will be carried out. When the EIA process is complete an environmental statement (ES) will be produced. The ES will set out an assessment of the scheme's environmental effects, along with proposed mitigation.


