- 3. Recipients are as at the second Thursday of the month.
- 4. SHBE is a monthly electronic scan of claimant level data direct from local authority computer systems. It replaces quarterly aggregate clerical returns. The data is available monthly from November 2008 and February 2013 is the most recent available
- 5. " " denotes nil or negligible.
- 6. The economic status of all Housing Benefit (HB) recipients is not available. Information is only available for those HB recipients whose claim is not passported: that is for those who do not receive either Income Support (IS), Jobseekers Allowance Income-Based (JSA(IB), Employment and Support Allowance Income-Based (ESA(IB), or Pension Credit (Guaranteed Credit) A small proportion of the passported cases will be in part-time employment.
- 7. State Pension has not been included in this analysis because it is not a passported benefit.

Notes:

- 1. Average length of claim is the median duration shown in days and includes claims that were live at some point during the period 1st January to 31st December for each year. Where a claim is still live at the end of the year the duration is taken as at the 31st December that year. Average duration of claims for 2013 is not available as the latest data available is February 2013.
- 2. The median duration indicates that half of the claims were shorter than this value and half were longer. Median is a better measure of "average" than arithmetic mean for skewed distributions such as duration of claim.
- 3. Durations are shown in the number of days and are rounded to the nearest whole number.
