Claire Gordon-Macgregor - BV21106914/1 - The Division holds information from a local authority that the deceased may have been divorced and may have had a son. We hold no information in relation to her maiden name. The Division holds no information in relation to an alternative address.

Agnes Hall - BV2022032/1 - The Division holds a copy of a birth certificate with a different date and place of birth from that shown on the death certificate and has no information to confirm that it relates to the deceased. As this information may relate to a living person, it is exempt from disclosure under section 40(2) of the Act. The information is exempt from disclosure because it constitutes the personal data of a living individual as defined in section 1(1) of the Data Protection Act 1998 and disclosure of the information would be in breach of the data protection principles set out in Schedule 1 of that Act. In particular, disclosure of the information would contravene the first data protection principle, which requires that personal data be processed fairly and lawfully.

Margaret Hanney - BV21401323/1 - The Division holds information provided by Leeds Council which states that the deceased was a widow.

Richard Wilson - BV2033894/1 – The Division holds information provided by Islington Council that the deceased was a Sergeant Major in the Army.

David Taylor - BV2076550/1 - It has not been possible to locate the papers despite an extensive search in relation to this estate. The Division is unable to confirm whether any additional information is held other than that already published.
