We can report based on local management information that in the period from 8 May 2015 to 21 March 2017 we have undertaken the following regulatory casework activity:

- 4 investigations of awarding organisations
- 134 audits of awarding organisations Investigations and audits may involve requests for data/ information as well as site visits.
- 119 recognition applications
   These include new applications for recognition, as well as applications for extensions of scope of existing recognition.
- 403 complaint and whistleblowing cases

These relate to complaints about an awarding organisation we regulate, the regulated system or our actions as the regulator. Most relate to awarding organisation decisions on marking, moderation and appeals across a range of qualifications and subjects.

Please note, the above data includes details of completed activity only. For the purposes of this report, we have counted an audit as complete where testing is finished.

Our records indicate that we have made in the region of 70 requests for data/ information from awarding organisations (including formal requests). This excludes requests made as part of the audits/investigations reported above and also excludes those relating to the pilot/ research activity listed under L3 below.

The activities recorded under the L1 exclusion for the period 8/5/2015 to 21/3/2017 do not represent any change to our enforcement/ casework policy or process.

# L2 Education & communications activities

We issued 6 communications to awarding organisations in 2015 in relation to the removal of the Regulatory Arrangements for the Qualifications and Credit Framework, closure of the unit bank and introduction of a Regulated Qualifications Framework and Total Qualification Time criteria.

We issued 4 communications to awarding organisations in 2016 about changes in regulation arrangements for vocational qualifications in Northern Ireland.

## L3 Activity related to Policy Development

#### **Consultations:**

We have consulted/ are consulting on proposals to implement the regulatory changes listed below:

- Removal of the Regulatory Arrangements for the Qualifications and Credit Framework and introduction of the Regulated Qualifications Framework/ Total Qualification Time criteria
- Removal of the Code of Practice for GCE & GCSE, setting of grade boundaries and changes to arrangements for reviews of marking/ moderation and appeals
- New and amended statutory guidance to 13 General Conditions of Recognition
- Changes to specifications for reasonable adjustments under S96 of the Equality Act 2010.
- Withdrawal of criteria for Entry Level qualifications
- Ofqual's statistical releases
- Amending statutory guidance for condition G4
- Updating rules & guidance for project qualifications
- Withdrawing principal learning and Diploma rules.

#### Pilots:

**Appeals:** We proposed to extend grounds on which appeals can be made to an exam board against a review of marking decision. A pilot was undertaken in 2016 for 3 A level subjects (Religious Studies, Physics, Geography). We are now evaluating before reaching a decision on implementation.

**Audit procedure:** We conducted a risk-based audit pilot. We included four awarding organisations and completed this pilot study in February 2017. We are now evaluating before reaching a decision on implementation.

#### Research activity:

We have undertaken research in the following areas which has involved engagement with/ requests for information from awarding organisations and/or schools:

- Validity of qualifications
- Proficiency specifications
- Mastery assessment (Functional Skills)

#### For GCSE/ GCE:

- Standards comparability
- Standard setting
- Quality of marking
- Moderation
- Reviews of marking, moderation and appeals
- Investigation into 'Sawtooth effect' in assessment
- Modular v Linear qualifications
- Summer awarding
- Predictability of examined assessments

#### **Other: National Reference Test**

Ofqual's National Reference Test (NRT) will provide additional information to support the awarding of GCSEs. The information from the test will be considered each year by Ofqual and the exam boards prior to GCSEs being awarded. The NRT will provide information on changes in performance standards over time and will be based on results from a nationally representative sample of students who will take the test shortly before taking their GCSEs. Currently, exam boards have limited evidence of how performance standards can change

	over time. The test will indicate if, over several years, there is a change in how students perform at the national level, which exam boards can then consider during awarding. Ofqual has appointed NFER to develop, administer and analyse the test on its behalf. To reflect the importance of the new test and to ensure high participation rates, the government has introduced legislation that requires the participation of state schools that are selected to take part. For maintained schools, this obligation is placed on the school directly through legislation. For the vast majority of academies and free schools, the requirement has effect through their funding agreements.
