## Register of Data Provision Notices

The Health and Social Care Information Centre (HSCIC), also known as NHS Digital, issues a Data Provision Notice each time it uses the statutory power under Section 259 of the Health and Social Care Act 2012. The register below records each time a Notice has been issued by the NHS Digital.

The Data Provision Notice includes the form, manner and period of the collection – and the organisations are required to supply data. We seek to notify the organisations required to provide data by email where we hold contact details.
