a) The number of a) Reaper b) Tornado, c) Typhoon missions flown;

b) The number of a) Reaper b) Tornado, c) Typhoon sorties with weapons released;

c) The number and type of weapons released by a) Reapers, b) Tornado, c) Typhoon

2) Please can you let me have the number of UK air strikes in a) Iraq and b) Syria per month from 1st September 2016 to 31 December 2016 broken down between Reaper, Tornado and Typhoon aircraft?

3) Please can you confirm if UK armed forces have utilised US unmanned aircraft since 1st September 2016 and if so, can you let me have monthly number of sorties/weapons releases?

Finally, can I ask for the following information only if it does not exceed cost limits? If it does, ignore the following request and only answer the above request as you have done previously.

4) Please can you tell me, for each month between 1st January and 31 December 2016 how many hours have UK a) Reapers, B) Tornado and C) Typhoon flown?"
