Thank you for your e-mail of 11 August asking for information about refuelling flights carried out by the RAF's VIP Voyager. You requested the following information:

"....how many times the RAF A330 Voyager refuelling aircraft, refurbished to carry members of the royal family and senior members of the Government, has been used for refuelling operations since it was remodelled for its new role.

Could you specify the date and year it was flown on refuelling operations, whether it was refuelling UK or foreign aircraft, and the nature of the operations the planes being refuelled were undertaking."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000. A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held.

Please find attached details of refuelling flights undertaken by Voyager ZZ336 which has been refitted to undertake the VIP role when required. In a small number of cases flights were undertaken but refuelling did not actually occur.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that the VIP Voyager is based alongside the rest of the Voyager fleet at RAF Brize Norton where it is routinely used for air-to-air refuelling, air transport and trooping flights. It undertook its first flight in the VIP role on 8 July 2016.
