

Permitting decisions

Surrender

We have decided to accept the surrender of the permit for Worsbrough Sludge Treatment Facility operated by Yorkshire Water Services Limited.

The permit number is EPR/KP3136LR

We are satisfied that the necessary measures have been taken to avoid any pollution risk and to return the site to a satisfactory state. We consider in reaching that decision we have taken into account all relevant considerations and legal requirements.

Purpose of this document

This decision document provides a record of the decision making process. It:

Key issues of the decision

Yorkshire Water Services Limited propose to surrender the permit for Worsbrough Sludge Treatment Facility for the Sludge Treatment Facility following the cessation of dewatering for disposal. The permit has been in operation since 23/02/07. The Sludge Treatment Facility will remain operational and managed by Yorkshire Water Services Limited with dewatered sludge sent for recycling only. Under the Environmental Permitting (England and Wales) Regulations 2016 this activity is exempt from requiring a permit.

In order to surrender the permit for the Sludge Treatment Facility it must be demonstrated that the necessary measures have been taken.

- (a) To avoid a pollution risk resulting from the operation of the regulated installation;
- (b) To return the site of the regulated installation to a satisfactory state, having regard to the state of the site before the installation was put into operation

We are satisfied that the necessary measures have been taken to avoid any pollution risk and to return the site to a satisfactory state. We consider in reaching that decision we have taken into account all relevant considerations and legal requirements.

Growth Duty	
Section 108 Deregulation Act 2015 – Growth duty	We have considered our duty to have regard to the desirability of promoting economic growth set out in section 108(1) of the Deregulation Act 2015 and the guidance issued under section 110 of that Act in deciding whether to grant this permit surrender.
	Paragraph 1.3 of the guidance says:
	"The primary role of regulators, in delivering regulation, is to achieve the regulatory outcomes for which they are responsible. For a number of regulators, these regulatory outcomes include an explicit reference to development or growth. The growth duty establishes economic growth as a factor that all specified regulators should have regard to, alongside the delivery of the protections set out in the relevant legislation."
	We have addressed the legislative requirements and environmental standards to be set for this operation in the body of the decision document above. The guidance is clear at paragraph 1.5 that the growth duty does not legitimise non-compliance and its purpose is not to achieve or pursue economic growth at the expense of necessary protections.
