Discretionary Housing Payments: end of year returns 2016/17

- 1. In the March issue of HB Direct we provided you with advance notice that the Discretionary Housing Payments (DHPs) 2016/17 end of year monitoring arrangements would be due for completion. These returns continue to improve the Department for Work and Pensions' (DWP) understanding of how DHPs are being used to support people affected by the welfare reforms.
- 2. In line with the mid-year format, local authorities (LAs) are asked to record if a successful DHP applicant had been affected by one of the welfare reforms together with the main outcome expected from that award.
- 3. The last monitoring period spanned 1 April to 30 September 2016. You are now asked to supply information in respect of the complete financial year 1 April 2016 to 31 March 2017. We are only seeking details of DHPs paid during this period, please do not include DHPs committed which are due to be paid after 31 March 2017. Further details can be found in the DHP Guidance Manual paragraphs 7.9 to 7.14 and the notes tab of the DHP monitoring form.
- 4. In line with the approach taken previously, the monitoring form asks for the value of DHP paid, broken down into welfare reform impact and purpose of the award. For example, award made as a result of implementation of the benefit cap with the purpose of helping the claimant secure and move into alternative accommodation. If the information relating to the purpose of the award is not available, LAs are asked just to record the total DHP paid in respect of the welfare reform listed.
- 5. Please complete and return the monitoring form, provided separately as Appendix A, by **Friday 12 May 2017**. The monitoring form should be submitted to dhp.monitoringinbox@dwp.gsi.gov.uk

2016/17 certification guidance to auditors

England and Wales

- 6. HB COUNT is the approach followed by auditors undertaking certification work on HB final subsidy claims (form MPF720A or C).
- 7. Module 1 for 2016/17 sets out the HB COUNT approach, including guidance on testing (for example, sample sizes, error types and amendments) and the format of qualification letters to be issued to DWP.
- 8. Module 1 has been agreed by DWP and issued to the auditors. Any LA that would like a copy of the 2016/17 Module 1 guidance information can request it from your appointed auditor at the preliminary meeting to set up the HB COUNT work for 2016/17.

Scotland

- 9. Module 1 does not apply in Scotland as Audit Scotland issues its own technical guidance which is available on Audit Scotland's website.

Update: Real Time Information service

- 11. All Revenues and Benefits Managers have received a Real Time Information (RTI) Service Business Readiness Approach document. The RTI service is initially being rolled out on 24 April 2017 to six LA test sites in Tranche 1:
 - Flintshire
 - Gateshead
 - Glasgow
 - Kensington and Chelsea
 - Leeds
 - Wrexham
- 12. Initial contact with the LA Implementation Single Point of Contact commenced on 27 March 2017 for all sites in Tranche 1.
- 13. Following Tranche 1 rollout there will be a review period to assess the success of this proposed approach. Rollout will then continue across all LAs from 22 May 2017 by geographical area. Each area will introduce the service based on the agreed schedule provided at Annex A.
- 14. Some preparation activities will be required by each LA in the lead up to your rollout, this includes obtaining access to the RTI service via Employee Authorisation Services.
- 15. For RTI rollout we have negotiated and agreed that the Customer Information System downtime will be reduced from 5 days to 1 day.
- 16. Detailed instructions for HB assessors to access the RTI service was issued to LA Sponsors and LA agents via the National Registration Authority Hub on 24 March 2017. It can also be found on Glasscubes.

Modernisation of the General Referral Matching Service

18. As the General Referral Matching Service contract is due to end, DWP Data and Analytics (D&A) will, in future, generate fraud and error referrals to LAs using data held in their data warehouse.

- 19. Although the outputs generated from the D&A data warehouse use different IT hardware and software, LAs will continue to receive the data as you do now.
- 20. Six LAs will test the new DWP generated outputs in May 2017, with the plan to move to this new service for all LAs in June 2017.

Tax-Free Childcare Scheme

- 22. HM Revenue & Customs (HMRC) is bringing in a new Tax-Free Childcare Scheme from April 2017. The scheme allows parents to create an account where they can set aside money to pay for childcare provision for their children and from which the payments are debited to a registered childcare provider. HMRC will top up these payments on an 80/20 basis up to a certain limit. For example for every £8 paid in, HMRC will add £2. They could receive up to £2,000 per child, or £4,000 if the child is disabled.
- 23. The scheme is open to working parents with children aged under 12, or under 17 if the children are disabled. Tax-Free Childcare can't be used at the same time as childcare vouchers or tax credits.

Impact on HB

- 25. For HB claimants the 80% contribution into the childcare account by a claimant should be treated as the claimant's capital. The remaining 20% provided by HMRC is not available to the claimant and can be disregarded.

HB decisions by the Upper Tribunal

- 27. Decision Making and Appeals Leeds is aware of the following HB cases that have been decided by the Upper Tribunal (UT):
 - CH/659/16: Removal Spare Room Subsidy (RSRS). Claimant appeal dismissed. Nelson followed
 - CH/2418/15: Claimant lost entitlement to HB as she had been in hospital for over a year. The UT decided that the HB Regulations indirectly discriminated against the claimant but the discrimination was justified

- CSH/481/16: Claimant appeal dismissed, claimant was under a continuing duty, should reasonably have been expected to realise that there was an overpayment at the material times
- CH/3309/16: Claimant appeal dismissed. Tribunal gave sufficient explanation why tenancy was not on a commercial basis
- CH/343/16: RSRS. Secretary of State Appeal upheld. Nelson followed
