- 3. On 25<sup>th</sup> October 2010, WORKSTEP, Work Preparation and the Job Introduction Scheme were replaced by Work Choice.
- 4. An individual can obtain a supported and unsupported outcome in the same reporting period. In this instance, they would be counted once in

the total job outcomes, and once in each of the supported and unsupported totals.

Please note that Work Choice does not have the same customer groupings as the Work Programme and operates differently. Work Choice is available to all disabled people who meet the qualifying criteria; regardless of what benefit they receive or even if they are not on any benefit. The customer groupings (in terms of previous benefit received) we publish are derived by merging the Work Choice data with the National Benefits Database to identify what benefit (if any) they have come from prior to being referred to Work Choice. For these reasons ex-IB JSA is not available; however JSA and DLA is available for analysis and is shown in table 2 above.
