Thank you for your letter of 17 October in which you asked for the following information:

How many M3 amphibious bridging vehicles were utilised in Operation Iron Wolf and Saber Guardian and which units used these vehicles?

How many M3 amphibious bridging vehicles have been based in Germany in each of the last 10 years?

How many M3 amphibious bridging vehicles (a) have been purchased, (b) are in service and (c) are held in reserve?

How many M3 amphibious bridging vehicles were deployed during NATO exercises

in each of the last 10 years: what the name of the (a) exercise and (b) unit was engaged in each of those exercises?

As you will be aware, on 16 October I provided answers to Parliamentary Questions you submitted asking for the same information as above. This information is, therefore, exempt under Section 21 of the FOIA as it is reasonably accessible to you by other means. With regard to the remainder of the information you have requested. My earlier response to Parliament advised that the Department does not routinely comment on specific levels of readiness and specific locations for individual capabilities as to do so would compromise operational security, or would, or would be likely to, prejudice the

Madeleine Moon MP House of Commons London SW1A 0AA capability, effectiveness or security of the Armed Forces. This relates to Section 26 (Defence) of the FOI Act. This is a qualified exemption that requires a public interest test to be conducted in order to consider the arguments both for and against the release of this information.

The Ministry of Defence has conducted that test. Arguments for the release of this information include the public interest in knowing how many vehicles are operational, how many are held in reserve and used in specific exercises, and the openness and transparency of releasing such information. Arguments against the release of such information include providing specific levels of readiness and numbers for individual capabilities would compromise operational security, as well as the effectiveness or security of the Armed Forces. Having considered the arguments both for and against release the Department has decided to withhold the number of vehicles that are in service, are held in reserve and involved in the exercises and operations as the information as it is likely to prejudice the security, capability and security of our Armed Forces. Release of this information would be likely to prejudice Defence matters.

The Public Interest Test determined that the Department could release information relating to the NATO exercises that M3 Amphibious Bridging Vehicles have deployed on in the last 10 years. I provide that information in the table below:
