DWP response

In response to part of your question, statistics on Council Tax Benefit (CTB) claimants aged 50 and over for November 2010 to February 2013 in the requested areas are shown in the table below. Please note that this is "point in time data" therefore we have provided this as at November for 2010, 2011 and 2012, with the final year for 2013 as at February as that is the last month this data is available.

- 6. Age groups are based on the age on the count date (second Thursday in the month), of either: (a) the recipient if they are single, or (b) the elder of the recipient or partner if claiming as a couple

In response to the part of your request requiring CTB data, by age, for 2008 and 2009, I can confirm that the Department does hold some information falling within the description specified in your request. However, the required information is not readily available on the datasets used for analysis and we estimate that the cost of complying with your request would exceed the appropriate limit of £600.

The appropriate limit has been specified in regulations and for central Government it is set at £600. This represents the estimated cost of one person spending 3½ working days in determining whether the Department holds the information, and locating, retrieving and extracting the information. Under section 12 of the Freedom of Information Act the Department is not obliged to comply with your request and we will not be processing this part of your request further.

Data prior to 2008 is not held by the Department as the data we received from local authorities was "stock count data" and not individual claimant level data as we receive now, which did not include age of claimant.

From the 1st April 2013 Council Tax Benefit (CTB) was abolished and replaced with a new scheme of Localised Council Tax Reduction (LCTR). In England the Department for Communities and Local Government (DCLG) is

now responsible for the statistics. The Scottish and Welsh Governments have similar responsibility.
