Information request

Under the freedom of information act, I request the number of people who are currently claiming disability benefits from a postcode that begins with E8 or E9, who cite alcohol misuse, or addiction as their main reason for claiming incapacity benefits.

If the cost has not yet been exceeded, please provide the total amount of benefits paid in the past two financial years (including this one that is yet to finish) to incapacity benefit claimants who have a postcode beginning with E8 or E9 and who cited alcohol misuse or addiction as their main reason for claiming benefits. If it is more cost effective, please only refer to figures from the past quarter.

If the cost limit has not yet been exceeded please provide the number of people currently claiming incapacity benefits who live in an area that begins with the postcode E8 or E9.

DWP response

- 3. ESA replaced IB/SDA for new claims from 27 October 2008.
- 4. Causes of incapacity are based on the International Classification of Diseases, 10th Revision, published by the World Health Organisation.
- 5. Under the Employment Support Allowance regime, new claimants have to undergo the Work Capability assessment. From April 2011 Incapacity Benefit recipients also began to undertake this assessment. The medical condition recorded on the claim form does not itself confer entitlement to Incapacity Benefit or Employment Support Allowance. So, for example, a decision on entitlement for a customer claiming Incapacity Benefit on the basis of alcoholism would be based on their ability to carry out the range of activities assessed by the Work Capability Assessment, or on the effects of any associated mental health problems. Please also note that where someone has more than one diagnosis or disabling condition, only the predominant one is currently recorded.

In response to your second question, benefit expenditure for financial years 2012-13 and 2013-14 for ESA and IB/SDA in postcode areas E8 and E9 is shown in the tables below.
