

NOTICE OF ORDER

HIGHWAYS 1981 SECTION 119

The East Riding of Yorkshire Council (Watton Footpath No. 11 and Bridleway No. 19) Public Path Diversion and Definitive Map & Statement Modification Order 2016

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **21 November 2017**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert:

(a) The full width of a section of Watton Footpath No. 11 commencing at Grid Reference TA 0633 4730 and leading north-north-westerly then north-easterly and northerly for a total of some 395 metres to Grid Reference TA 0641 4765 to a line some 510 metres in length commencing on a bridleway also created in this Order at Grid Reference TA 0621 4727 and leading north-north-easterly to and over Starberry Drain and turning northerly along the eastern bank to join Watton Footpath No. 11 at Grid Reference TA 0641 4765; and

(b) The full width of a section of Watton Bridleway No. 19 commencing at Grid Reference TA 0622 4718 and leading north-easterly for some 100 metres to Grid Reference TA 0628 4725 to a line some 220 metres in length commencing at the parish boundary at Grid Reference TA 0622 4718 and leading north-easterly then north-westerly to Grid Reference TA 0619 4726 turning north-easterly to Grid Reference TA 0621 4728 then south-easterly and north-easterly to re-join Bridleway No. 19 at Grid Reference TA 0628 4725, as shown on the Order map.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 05 December 2017]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Orders.

Within 8 weeks of the start date [by 16 January 2018]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Orders.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Orders (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 27 February 2018]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Orders must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Orders must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

This Order is made by The East Riding of Yorkshire Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the public it is expedient that the line of the ways should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Humberside County Council Borough of East Yorkshire Definitive Map and Statement of Public Rights of Way require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

Watton Parish Council have been consulted and have consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public rights of way over the land situated at Watton in the East Riding of Yorkshire and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after seven (7) days from the date of confirmation of this Order and thereupon

The Humberside County Council Borough of East Yorkshire Definitive Map shall be modified by deleting from it those public rights of way.

2. There shall at the end of seven (7) days from the date of confirmation of this Order be a public footpath and a public bridleway over the land situate at Watton described in Part 2 of the Schedule and shown by a bold broken line on the Map contained in this Order and thereupon The Humberside County Council Borough of East Yorkshire Definitive Map shall be modified by adding those ways to it.
3. The Humberside County Council Borough of East Yorkshire Definitive Statement shall be modified as described in Part 4 of the Schedule to this Order.
4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.
5. For the purposes of this Order the relevant date is the date upon which the Order comes into effect.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

- (a) The full width of a section of Watton Footpath No. 11 commencing at Grid Reference TA 0633 4730 (Point A on the Map) and leading north-north-westerly then north-easterly and northerly for a total of some 395 metres to Grid Reference TA 0641 4765 (Point B on the Map).
- (b) The full width of a section of Watton Bridleway No. 19 commencing at Grid Reference TA 0622 4718 (Point C on the Map) and leading north-easterly for some 100 metres to Grid Reference TA 0628 4725 (Point D on the Map).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

(a) A section of footpath in the parish of Watton some 510 metres in length commencing on a bridleway also created in this Order at Grid Reference TA 0621 4727 (Point E on the Map) and leading north-north-easterly to and over Starberry Drain and turning northerly along the eastern bank to join Watton Footpath No. 11 at Grid Reference TA 0641 4765 (Point B on the Map).

The footpath will have a width of 2 metres.

(b) A new section of bridleway in the parish of Watton some 220 metres in length commencing at the parish boundary at Grid Reference TA 0622 4718 (Point C on the Map) and leading north-easterly then north-westerly to Grid Reference TA 0619 4726 (Point F on the Map) turning north-easterly to Grid Reference TA 0621 4728 (Point G on the Map) then south-easterly and north-easterly to rejoin Bridleway No. 19 at Grid Reference TA 0628 4725 (Point D on the Map).

The bridleway will have a width of 3 metres.

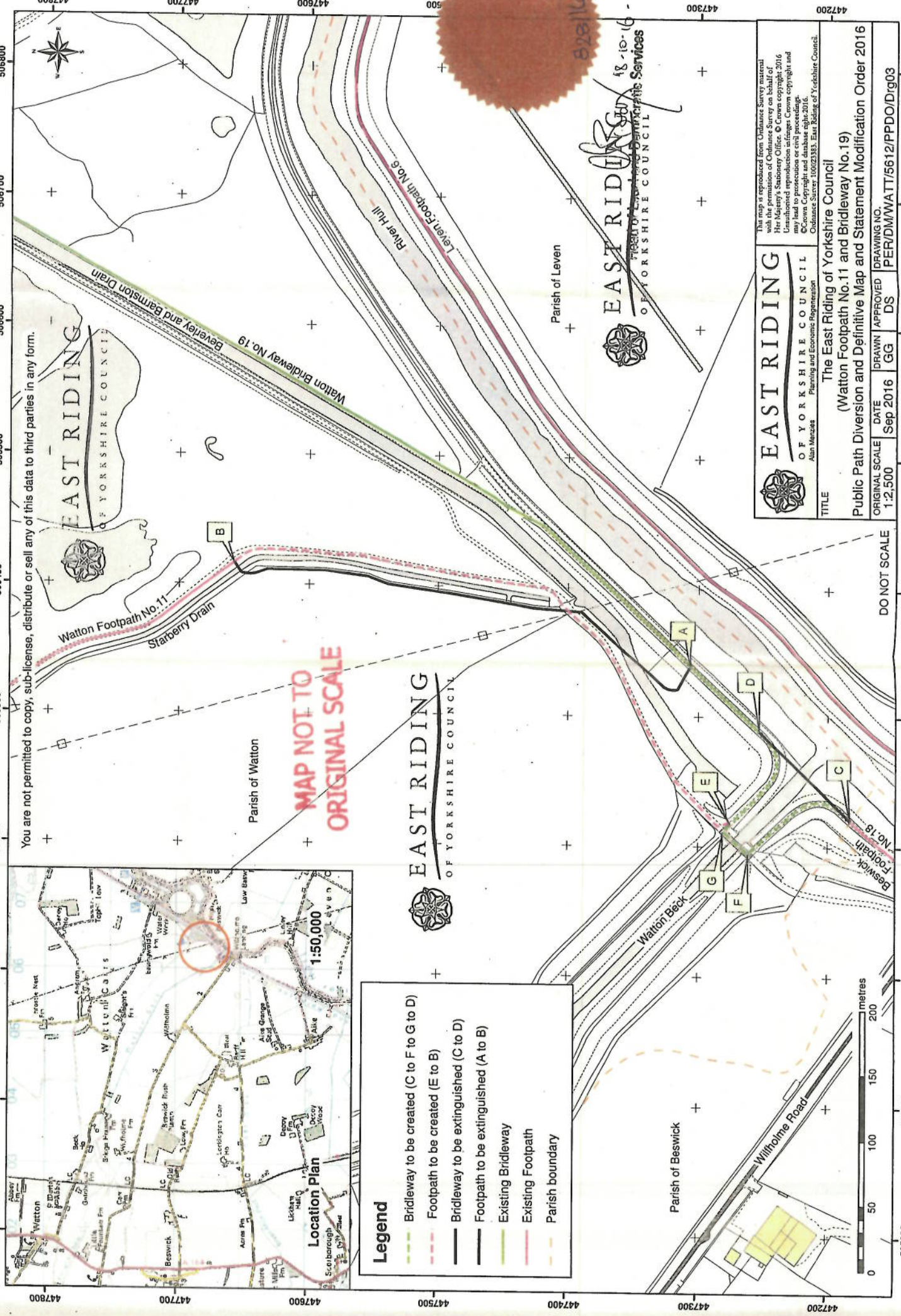
