## FREEDOM OF INFORMATION ACT 2000 - REQUEST REF: FOI 0187-17

Thank you for your email of 17 February 2017 asking for information under the Freedom of Information Act (FOIA) 2000. You wrote:

- 1. The number of minors abducted from the UK by their parents, with dual nationality in the last 5 years.
- 2. What nationality (as well as British) did they hold?
- 3. The number of cases where the Home Office succeeded in returning a child to the UK, the number where they did not succeed and the number of cases that are ongoing.
- 4. Whether there was any indication in any of the cases that the child was being held against their will.

## **Outcome of search**

We have now completed the search for the information you request and I can confirm that the Foreign and Commonwealth Office (FCO) does hold information relevant to your request.

**Q1** - The table below shows the total number of minors abducted from the UK by parents, with dual nationality in the last 5 years.

This data has been collected from the FCO's global consular assistance database, and includes cases that were recorded by consular officers where the main or secondary reason that consular assistance was provided was in connection with child abduction or child custody.

Please note that where the number of reported cases is less than or equal to five, these are annotated as <=5, to avoid the risk of identifying the individuals concerned. To release this data would contravene one of the data protection principles. In such circumstances Sections 40(2) and (3) of the Freedom of Information Act apply. In this case, our view is that disclosure would breach the first data protection principle. This states that personal data should be processed fairly and lawfully. It is the fairness aspect of this principle, which, in our view, would be breached by disclosure. In such circumstances, S.40 confers an absolute exemption on disclosure. There is, therefore, no public interest test to apply.

**Q2 & Q4** – **Withheld Information (Exceptions applied).** Section 40 - Personal information. The information found contained personal data relating to third parties, the disclosure of which would contravene one of the data protection principles. In such circumstances sections 40 (2) and (3) of the Freedom of Information Act apply. In this case, our view is that disclosure would breach the first data protection principle. This state's personal data should be processed fairly and lawfully. It is the fairness aspect of this principle, in our view, that would be breached by disclosure. In such circumstances, s. 40 confers an absolute exemption on disclosure. There is, therefore, no public interest test to apply.

**Q3** – The Ministry of Justice is the lead department for the Hague Convention on the Civil Aspects of International Child Abduction and you may find it more useful to request information from them. ## **Disclosure**

There is no requirement for child abductions to be reported to the FCO. We are only aware of cases where someone has contacted our Consular service for advice and therefore this data is unlikely to be representative of the number of child abductions which have occurred. There may be additional cases of dual nationality which were not declared to us.
