I am writing to confirm that we have now completed our search for the information, which you requested on 22 April 2017. Your request has been dealt with under the terms of the Freedom of Information Act 2000 (FOI).

- You have asked many crashes have there been on the M4 in Berkshire per month between March 2015 and March 2017. Of those, how many involved fatalities?
- How many crashes have there been on the A34 in Berkshire per month between March 2015 and March 2017. Of those, how many involved fatalities?

Highways England obtain their validated incident statistics from the Department for Transport (Stats 19) which provides detailed information on incident circumstances, vehicles involved and resulting casualties. There is no legal requirement to report of non-injury incidents to the Police but all incidents involving personal injury must be reported.

I enclose a copy of the validated accident figures for the A34 and M4 in Berkshire for the period between March 2015 and December 2015. This also includes the unvalidated figures for the number of fatal accidents between January 2016 and March 2017, however we do not hold the figures for the total number of accidents within this timeframe.

Please note that the unvalidated data may be incomplete and subject to change and precise locational information is not always available. If the accident occurred near a local authority boundary there may be some inaccuracies as to which authority the accident occurred in.

The validated accident data for 2016 is due to be released in the Autumn and once we have received this information we will be able to update you. The validated 2017 data will be issued in Autumn 2018.
