In 2003 General De Chasterlain sent a report of concern to NIO.

- (1) The sabotage weapons planned by IRA were not included in the Declaration and Decommissioning Terms of Reference of Good Friday Agreement
- (2) Whether his terms of reference empowered his Decommissioners to deploy to Kent to investigate arrests within Kent Territorial Army 1987. The collusion lines of inquiry that may exist given the arrests by Metropolitan Police of UDA drugs pushers and hit men at their Margate Kent base 1992.
- (3) Live fire paramilitary training in Kent at suspect sites 6th Thanet Range, Broad Oak land and Stone Lodge Range Dartford and whether this involved collusion with proscribed groups and mercenaries who attacked Mandela regime in 1990s (given apartheid regime history of arming UDA proscribed in 1992 the year of the above arrests at Margate Kent)
- (4) The history of Deal Royal Marines Barracks use and its 1989 terrorist bombing and the relationship between paramiltary/collusion training at the barracks to the later bombing. The weapons supply and transfer associated with this.
- (5) The 30 year history of Kent Police firearms certificate issues.

I am interested to learn if Gen De Chasterlain was advised by NIO that activity in Kent was exempt from GFA because it was security force personnel. We now know that such advice would have been wrong because of clarification from Secretary of State for Defence 2009 that the activity originated in Deal RM Barracks had no Crown authority. This is the offence defined then by UNlawful Drilling Act 1819. If activity was in contravention of that act then it cannot have had GFA exemption. Rather suggesting to me that Gen De Chasterlain was entitled to deploy to Kent under GFA.

In 2001 post 9 11 inquiries by Metropolitan Police and Dyfed Powys Police were into uzis and middle easterners training at Yetgoch Wales. The fact is that the same name(s) had already been associated with use of Kent gun ranges in the 1990s. Scotland Yard are certainly aware of this now from my report to Sir Bernard Hogan Howe and from my Fols. They have exempted themselves on security grounds from answering whether they are cross referring the Kent paramilitary training history into the post 9.11 Mark Yates Frank Etim case.



# I wish to know the advice NIO gave Gen De Chasterlain in 2003. I imagine that this would be from his NIO liaison contacts?

Do the judiciary and senior civil servants receive enhanced physical protection for their houses at public expense upon appointment or is it the subject of a security analysis?

The department does hold some information falling within the scope of your request. I have provided you with a digest of the Home Protection Scheme below.

## Digest of the Scheme

- 1. Background to and scope of the Home Protection Scheme
- 1.1 Successive Secretaries of State have operated and financed a home protection scheme since the early 1970s, as a response to the level of terrorist threat in Northern Ireland. In the past the Scheme has been known as the VIP Scheme and the Key Persons Protection Scheme (KPPS). The Scheme became known as the Limited Home Protection Scheme (HPS) in 2006, and the Home Protection Scheme in 2011.
- 1.2 The Scheme is limited, non-statutory and discretionary, aimed at protecting the primary residence (and occasionally the workplace and exceptionally a secondary residence) of certain individuals who fulfil the eligibility criteria (see section 2 below). The HPS



cannot and does not provide total protection, nor does it seek to protect all persons in Northern Ireland who may be under some degree of threat.

# 2. Eligibility for inclusion in the HPS

- 2.1 There are two eligibility criteria which should be satisfied before an individual will be admitted to the HPS. The first is the individual's occupation or position within either Government or the criminal justice system in Northern Ireland. In general, the Scheme aims to provide protection for those in the public service concerned with the effective administration of Government and the criminal justice system, upholding law and order and maintaining the democratic framework.
- 2.2 Applications will also be considered for individuals who do not have an occupation or hold a position such as is contemplated in paragraph 2.1 but where their occupation or position is nonetheless considered to be of sufficient importance to the administration of Government and where it is in the public interest that the position is one to which the scheme should be available.
- 2.3 The second criterion for admission is the threat level applicable to that individual, as assessed by the Security Service. Where the threat assessment indicates that the Northern Ireland-related terrorism (NIRT) threat to an individual is at SUBSTANTIAL, SEVERE or CRITICAL, levels, and the applicant is in one of the occupational categories included in the Scheme admission is automatic and is without reference to the Minister.
- 2.4 In all other cases, decisions on whether an individual should be included within the Scheme are made by the Minister of State. In all cases where the Security Service assess the NIRT threat to an individual at MODERATE or LOW, or where the applicant is at a SUBSTANTIAL threat level (or higher) but does not fall within one of the stated occupational categories, the Minister must use his discretion to decide on admission to the Scheme.
- 2.5 Where the individual is deemed to be under a real and immediate threat (ie they are assessed to be at a Moderate threat level or higher) the Minister will make his decision taking into account the Government's obligations under Article 2 (Right to Life) of the European Convention on Human Rights. Article 2 is not engaged at a Low level of threat; however, the Minister still considers such applications.



The judiciary and senior civil servants are in occupations which fulfil the first criteria for admittance to the Scheme but admittance will depend on them applying and the outcome of any security threat assessment.
