Thank you for your email of 8 November 2017 requesting the following information:

*Under the Freedom of Information act please could I request a full list of all the sub-contractors / suppliers that are or have been involved on the new Military Houses in Tidworth under the main contractors Hill Partnerships.*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all the information in scope of your request is held.

The information you have requested can be found at Annex A, but some of the information falls entirely within the scope of the absolute exemption provided for at section 40 (Personal Data) of the FOIA and has been redacted.

Section 40(2) has been applied to some of the information in order to protect personal information as governed by the Data Protection Act 1998. Section 40 is an absolute exemption and there is therefore no requirement to consider the public interest in making a decision to withhold the information.
